COMMITTEE'S FUNCTIONS AND POWERS

The Public Accounts Committee inquires into and reports to the Legislative Assembly on any proposal, matter or thing it considers necessary, connected with the receipt and expenditure of public moneys, including moneys allocated under the annual Appropriation bills and Loan Fund. Standing Order 286 of the Legislative Assembly states that:

The Committee may -

- Examine the financial affairs and accounts of government agencies of the State which includes any statutory board, commission, authority, committee, or trust established or appointed pursuant to any rule, regulation, by-law, order, order in Council, proclamation, ministerial direction or any other like means.
- 2 Inquire into and report to the Assembly on any question which -
 - (a) it deems necessary to investigate;
 - (b) (Deleted V. & P. p. 225, 18 June 2008);
 - (c) is referred to it by a Minister; or
 - (d) is referred to it by the Auditor General.
- Consider any papers on public expenditure presented to the Assembly and such of the expenditure as it sees fit to examine.
- 4 Consider whether the objectives of public expenditure are being achieved, or may be achieved more economically.
- The Committee will investigate any matter which is referred to it by resolution of the Legislative Assembly.

CHAIRMAN'S FOREWORD

This annual report provides a summary of the work of the Public Accounts Committee over the 2009-10 financial year. It is not intended to give details of the workings of the PAC over this period.

At its core the role of the PAC is to "Consider whether the objectives of public expenditure are being achieved, or may be achieved more economically".

Where agencies of government or government programs are achieving good or even excellent results with public money, it is appropriate for the PAC to acknowledge and congratulate those responsible. However, while reinforcing good conduct and outcomes are worthwhile, it is doubtful that the PAC would get the best return for the resources and effort expended if it did not search out potential misspending or inefficient use of public money.

I believe the PAC better fulfils its stated functions when it seeks to highlight how better or more efficient use could be made of public money. To follow this approach requires the good will and support of the members of the PAC.

The current PAC is the first to have a majority and chair from the Opposition. While PAC members have worked in a cooperative spirit, the nature of this membership structure creates new tensions for its functioning.

Government members have a natural loyalty to the government of the day and feel an obligation to protect the government. Opposition members likewise have an incentive to advance their political position by embarrassing the government through identifying examples of failure or maladministration. This is a tension that the Committee recognises and continues to work through to ensure that the Committee produces reports that are valuable to the Parliament and the government.

This has sometimes resulted in votes on party lines when determining a report to the Legislative Assembly and even a minority report in one case. The clear presentation of the assembled facts always leaves it open to the House, the media and the public to make their own judgement on an issue.

I thank all the members of the PAC for their contributions to our work over the year. Very special appreciation is due to the staff whose commitment and professionalism has enhanced the work of the PAC. All members are most thankful to Mathew Bates who was the Research Officer for the entire year and Katherine Galvin, Isla Macphail and Loraine Abernethie who shared the role of Principal Research Officer through this period.

CHAPTER 1 COMMITTEE ACTIVITIES

1.1 Introduction

During the course of this reporting period (Table 1.1), the Committee:

- completed 3 Inquiries;
- held 29 deliberative meetings;
- has taken evidence from/or was briefed by 44 persons;
- attended one conference;
- followed up with approximately 100 agencies in relation to their implementation of the Auditor General's recommendations;
- hosted a Treasury information session on State Budget Estimates for all Members of Parliament on Tuesday 25 May 2010; and
- hosted Parliamentary delegations from:
 - o Parliamentary Committee C of the National Parliament of Timor-Leste; and
 - o Public Accounts Committee of the Sabah State Legislative Assembly

The Committee did not undertake any investigative travel during this year.

1.2 Public Hearings

1.3 Briefings

In addition to gathering evidence during the formal hearings, the Committee received a number of informal briefings. The briefings were used to gain information in relation to the Committee's inquiries as well as other matters (Table 1.3).

One of these briefings, that with the Department of Commerce, was provided during a site visit to the Australian Marine Complex in Henderson. This visit allowed the Committee to obtain valuable insight into the development and operation of the Complex.

Following a briefing with the Auditor General, under section 20 of the *Auditor General Act* 2006, the Committee requested the Auditor General consider including in his Forward Work Program an audit of municipal waste recovery plants.

The Committee secretariat also received informal briefings throughout the reporting period, including regular meetings between the Principal Research Officer and senior officers from the Office of the Auditor General.

1.4 Conferences

Three members of the Committee, together with the Secretariat, attended the WA Major Projects Conference 2010: Securing the State's Economic Future from 29–30 March 2010 at the Perth Convention Centre.

Western Australia is the host jurisdiction for the 2011 ACPAC Biennial Conference, and in consultation with the Estimates and Financial Operations Committee, the Committee has begun preparatory work on conference arrangements. The Committee is scheduled to attend the mid-term meeting in Hobart in July 2010.

1.5 Reports Tabled

The Committee tabled 5 reports during the period 1 July 2009–30 June 2010. They were as follows:

- Report No. 7—Inquiry into Government Payments to Ms Tirzah Bell.

1.6 Work in Progress

The Public Accounts Committee resolved on 25 November 2009 to conduct an Inquiry with the following terms of reference:

The Public Accounts Committee will examine and report on the best approaches to decision making for major infrastructure projects in Western Australia, with particular reference to:

- 1. the robustness of project planning and assessment processes; and
- 2. whether funding cases are appropriately developed and presented to maximise access to Federal Government funding.

To date, the Committee has taken evidence from a number of government agencies in relation to their infrastructure planning procedures and infrastructure funding arrangements. The Committee intends to table the Inquiry report in October 2010.

1.7 Post-Budget Briefing

The Public Accounts Committee hosts the Department of Treasury and Finance's post-budget briefing each year to familiarise Members of the Legislative Assembly with the Budget Estimates Papers. The Committee acknowledges the ongoing involvement of the Department of Treasury and Finance with this year's briefing being presented by Mr Anthony Kannis, Executive Director Treasury—Infrastructure and Finance—and Mr Sean Cameron, Acting Executive Director—Strategic Policy and Evaluation.

CHAPTER 2 FINANCIAL STATEMENT

The Public Accounts Committee does not have its own formal budget and is funded out of the budget of the Legislative Assembly. Approval for major expenditures is required on a case-by-case basis and is entirely at the discretion of the Speaker.
