There have been 6 applications for crime-used property substitution.

Three applications related to sex offences, 2 related to the manufacture of drugs and 1 related to a bribery charge.

#### Sex Offence 1

Offences	4 counts of indecently dealing with a child over 16 years of age under their authority, 2 counts of sexual penetration of a child over 16 years of age under their authority and 3 counts of indecent assault. Convicted: on 2 counts of indecently dealing with a child over 16 under his care, supervision or authority, 2 counts of sexually penetrating the same child and 2 counts assaulting the same child.
Sentence	18 months' imprisonment.
Interested Parties	Spouse on title as a joint tenant. Property subject to a mortgage.
Result / Current Status	Reviewing submissions from objectors in regards to undue hardship.

#### Sex Offence 2

Offences	4 counts of sexual penetration of a child over 13 and under 16 years of age.
Sentence	2 years 4 months' imprisonment.
Interested Parties	Spouse on title as a joint tenant. Property subject to a mortgage.
Result / Current Status	Awaiting submissions from objectors in regards to undue hardship.

#### Sex Offence 3

Offences	2 counts of sexual penetration of a child under the age of 13 years, 1 count of indecently dealing with a child over the age of 13 years and under the age of 16 years, 4 counts of indecent assault and 2 counts of sexual penetration without consent. Convicted: One count of indecent dealing with a patient who was 14 years of age and 4 counts of indecent assault and 2 counts of sexual penetration all against another patient aged about 18 to 20 years at the time of the offences.
Sentence	4 years 6 months' imprisonment.
Interested Parties	Spouse on title as a joint tenant. Property subject to a mortgage.
Result / Current Status	Terminated as a result of hardship.

#### Drug Offence 1

Offences	Manufacturing a prohibited drug, namely methylamphetamine.
Sentence	4 years' imprisonment.
Interested Parties	Spouse on title as a joint tenant. No Mortgage.
Result / Current Status	Matter is proceeding as the property which is frozen is not the principle residence and therefore does not involve undue hardship. Consent sale orders have been made with the other party to realise the offender's interest.

## Drug Offence 2

Offences	Manufacture a prohibited drug and cultivate a prohibited plant with intent to sell or supply.
Sentence	18 months' imprisonment conditionally suspended for a period of 24 months and a fine of \$750.
Interested Parties	Spouse on title as a joint tenant. Property subject to a mortgage.
Result / Current Status	Matter is proceeding. Prior to the property being frozen the offender and his wife reached an informal property settlement agreement whereby the property was to be sold and he paid his interest. Having regard to that agreement the hardship issue does not apply.

The bribery offence did not involve land or any other interested parties. The crime-used property substitution declaration was made in relation to funds that the offender passed on to the person being bribed. The funds were recovered from a bank account in the offender's name.
