
**SUBMISSION TO PARLIAMENT
UNDER SECTIONS 31(2)
OF THE LAND ACT 1933**

The proposal detailed in this report is required by the above provisions to be laid before each House of Parliament.

Section 31(2) of the Land Act 1933 provides as follows:-

31(2) Whenever the Governor has reserved or may hereafter reserve to Her Majesty any lands of the Crown and such lands are not classified as of Class A, the Governor may, by proclamation, at any time he thinks fit, classify such lands as of Class B, and if so classified, such lands shall remain reserved from alienation or from being otherwise dealt with unless and until the Governor, by proclamation, cancels such reservation. Provided that, in such case the Minister shall present a special report to both Houses of Parliament setting forth the reasons for such cancellation, and the purpose to which it is intended to devote the land; and such report shall be made to both Houses of Parliament within 14 days from the cancellation, if Parliament is then in session, and, if not, within 14 days after the commencement of the next session.

CANCELLATION OF CLASS B RESERVE 7324 FOR INCLUSION INTO PASTORAL LEASE CL250/1976

It is proposed to cancel Class B Reserve 7324, being Lot 207 on Deposited Plan 103892, and include into the adjoining Pastoral Lease CL250/1976.

Class B Reserve 7324 is currently unvested with the responsible agency being Water and Rivers Commission (Commission) with the purpose of "*Water Act 57 Vic No 20*". The Department of Water has requested that the Commission be removed as the Responsible Agency. A copy of a plan showing the reserve is at Attachment 1.

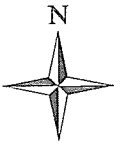
As the reserve is no longer required, the surrounding Pastoral lessee has agreed to inclusion of the land into his Pastoral Lease CL250/1976.

As Reserve 7324 has a Class 'B' status, it is necessary to report the cancellation to both Houses of Parliament.
