**ELECTRICITY CORPORATIONS (ELECTRICITY GENERATION AND RETAIL CORPORATION) REGULATIONS 2013**

**EXEMPTION**

Pursuant to regulation 47 of the *Electricity Corporations (Electricity Generation and Retail Corporation) Regulations 2013*, the Electricity Generation and Retail Corporation is hereby granted an exemption from regulations 13(1), 14 and 17(2) of the *Electricity Corporations (Electricity Generation and Retail Corporation) Regulations 2013* to the extent necessary to enable the Electricity Generation and Retail Corporation to fulfil its obligations to supply electricity to the following entities for the purpose of their own consumption:

- (a) RATCH-Australia Kemerton Pty Ltd (ACN 106 619 112) as trustee for the RATCH-Australia Kemerton Trust under a Power Purchase Agreement dated 8 December 2003 (as stated as at the date of this exemption) for the supply for electricity to premises located at Marriott Road, Kemerton;
- (b) BHP Billiton Aluminium (RAA) Pty Ltd (ACN 095 831 119), BHP Billiton Aluminium (Worsley) Pty Ltd (ACN 088 336 921), Japan Alumina Associates (Australia) Pty Ltd (ACN 008 907 524) and Sojitz Alumina Pty Ltd (ACN 009 309 344) under a Master Energy Agreement for the South West Cogeneration Project dated 24 June 1999 (as stated as at the date of this exemption), and ancillary agreements entered into by the Electricity Generation and Retail Corporation, for the supply of electricity to premises located at Wellington Location 5314;
- (c) Colltech Australia Limited (ABN 24 094 515 992) under a Lease Agreement dated 17 June 2004 (as stated as at the date of this exemption) for the supply of electricity to premises located at Collie Power Station, Williams Road, Collie;
- (d) Telstra Corporation Limited (ACN 051 775 556) under a 'Licence for the use of Collie Power Station Stack – Mobile Phone Equipment' dated 1 June 1998 (as stated as at the date of this exemption) for the supply of electricity to premises located at Collie Power Station, Williams Road, Collie;
- (e) Water Corporation as established under the *Water Corporation Act 1995* (ABN 28 003 434 917) under the Bilateral Trading Agreement dated 16 May 2011 and the Confirmation to the Bilateral Trading Agreement dated 16 May 2011 (as stated as at the date of this exemption);
- (f) Perth Power Partnership under the Power Purchase Agreement dated 10 March 1995 (as stated as at the date of this exemption); and
- (g) any other person under an agreement where that other person will consume the electricity:
  - (1) on premises on which generating works are located and those generating works are the subject of a generation licence granted to the Electricity Generation and Retail Corporation; and

- (2) for the primary purpose of providing goods or services to the Electricity Generation and Retail Corporation which are ancillary to the generation of electricity by the Electricity Generation and Retail Corporation.



**EXEMPTION**

Pursuant to regulation 47 of the *Electricity Corporations (Electricity Generation and Retail Corporation) Regulations 2013*, the Electricity Generation and Retail Corporation is hereby granted an exemption from regulation 17(2)(b) of the *Electricity Corporations (Electricity Generation and Retail Corporation) Regulations 2013* to permit Kurt Baker, Acting General Manager Wholesale Business Unit, to have day to day management responsibility for the Generation Business to the extent necessary to conclude the Kwinana Strategic Oil Reserve Tank Lease and Diesel Sale arrangement for the period 1 January 2014 to 30 June 2014.
