- (iii) In the Lower South West, specialist mental health services are provided by the Department of Health's Community Mental Health Team and by a range of private Psychiatrists and mental health practitioners.
- (iv) The WA NDIS My Way individual planning process incorporates a focus on the needs of family members and carers as key supports for the person with a disability. If required, support will be provided to families and/or carers.
- (v) Individualised services planned to enable a person with disability (including people with psychosocial disabilities) to achieve the outcomes they want to achieve and should include preventative strategies. These are agreed between the person and their chosen provider.
- (vi) The Commission does not record data on services provided outside its contracted arrangements.
