Hi

Yep, accessing how many and the names and dobs of Wards of the State (now known as Children in Care), and if possible, the names of any shared open cases from the 10th March to now, is what I am looking to access. I don't know if your system identifies open cases to DCP (that is open to case management only but not Wards) which will also assist in defining the purpose of a full time FTE. If a 'shared client' (either Ward or open case) has come in and out of the system since the Liaison Officer has been in their, I would want to identify that as well.

If you can only provide me with the names of the Wards from the list that you do have, and getting the other information will cause a delay or problems, then I will go with what you have. We have such a short time to get this Business Case up before the pilot finishes I will have to go with what I can get. If however you can give me a single list of all entries and exits for all the kids, I can go through and clarify shared cases, and then provide that information back to you. The problem with identifying 'open cases' is that they can close at any time and I am not sure how I could let you know when they close as we don't get notified by our system when cases are closed. We only find that information out when we go through a list to specifically identify what their current status is, so it isn't terribly helpful to you.

By the way, do you get forwarded the list of Shared Clients that I am providing each week to your Case Planning at Banksia Hill? If not, would you like me to add your name into the email (if of course it is useful to you)?

Is it possible to get a list of all young people that have been incarcerated since the 10th March until we got regular access to the list? The unit is wanting to know how many Children in Care and open cases we share over the months the project has been occurring, and what the average is per week. This goes to the argument of the need for a full time FTE out there.

I am happy to identify all the CIC and open cases from the list, I just need access to all the kids names, not even the dates on the current listings we get (except DOB of course).
