CORRUPTION AND CRIME COMMISSION
TABLED PAPER NO 3816 - DEEMED TABLED IN THE LEGISLATIVE COUNCIL ON 23 APRIL 2020

I refer to Tabled Paper no 3816.

The report, as tabled, does not reflect the final form intended by the Commission to be provided to Parliament.
