## RECOMMENDATION UNDER SECTION 4D OF THE WESTERN AUSTRALIAN FUTURE HEALTH RESEARCH AND INNOVATION FUND ACT 2012

I write to the Western Australian Future Health Research and Innovation (FHRI) Fund Advisory Council (Advisory Council) with regard to section 4D of the Western Australian Future Health Research and Innovation Fund Act 2012 (the Act), which states:

#### 4D. Requirements to be met before FHRI Account applied

- (1) Before making or approving arrangements under section 4C(1) that will operate during a financial year, or applying during a financial year money standing to the credit of the FHRI Account under section 4C, the Minister for Health must
  - (a) direct the advisory group to make a recommendation on how money standing to the credit of the FHRI Account should be applied during the financial year under section 4C; and
  - (b) consider the advisory group's recommendation.
- (2) A direction under subsection (1)(a) may
  - (a) include proposals for how money standing to the credit of the FHRI Account is to be applied during the financial year under section 4C; and
  - (b) require the advisory group's recommendation to state 1 of the following
    - (i) that money standing to the credit of the FHRI Account should be applied during the financial year in accordance with the proposals:
    - (ii) that money standing to the credit of the FHRI Account should not be applied during the financial year in accordance with the proposals;
    - (iii) that money standing to the credit of the FHRI Account should be applied during the financial year in accordance with the proposals as the proposals are modified as specified in the recommendation...

Pursuant to section 4D(1) of the Act, I direct the Advisory Council to provide recommendations to me on how money standing to the credit of the Future Health Research and Innovation Account should be applied during current and future financial years.

Your recommendations will be provided to me when new or renewed Programs and/or Initiatives require my approval. This standing request may be retracted or amended and does not restrict the Minister for Health's ability to request additional recommendations under 4D(1), which may include the conditions contemplated under 4D(2).

I look forward to receiving and considering the Advisory Council's recommendations.

#### Proposed 2021/22 to 2023/24 FHRI Fund Priorities

Enhance clinical trial capacity and expertise to improve the quality of clinical trials in WA and make the State more attractive to funders of clinical trials (grant funding and commercial sponsors).

Enhance health and medical research literacy, skills and experience of consumers so that they engage more in research.

Enhance skills in innovation (including commercialisation), which will advance the quality and capacity of innovation in WA and help WA innovators to obtain funding to support their work.

Establish an innovation seed fund to support early stage ideas and enable these innovative ideas to secure follow-on funding from commercial/other funders.

Establish co-funding partnerships that will secure genuinely new non-government funding for research and innovation aligned with Priorities for the FHRI Fund.

Provide cash commitments for submission to major competitive co-funding programs, making Western Australian-led applications more competitive and, therefore, increasing the State's share of national and international competitive funding.

Support the development of early- and mid-career researchers, helping them to achieve an independent and self-sustaining career.

Target high-performing researchers in WA to maintain and/or advance the State's position as a leader in health and medical research.

Address, through research and innovation, key health issues and inequalities for Aboriginal Western Australians.

Rapidly and sustainably build mental health research and/or innovation capacity in WA.

#### FUTURE HEALTH RESEARCH AND INNOVATION FUND FUNDING PRINCIPLES

#### 1. Open and Transparent

Ensure that the application and review processes are open and transparent, widely advertised and accessible to all relevant applicants to be able to identify the highest quality ideas and projects.

#### 2. High-Quality

Implement a competitive and merit-based application and review process, ensuring that the best quality applications are funded, and that funding is only awarded if high-quality proposals are received.

#### 3. Independent Review

Implement independent expert peer review to secure the integrity of the review and assessment process.

#### 4. Partnerships and Collaboration

Give priority to proposals that demonstrate partnerships (whether formal or informal) and working collaboratively with others to maximise impact, including incentivising co-investment from the academic, research, government, private and philanthropic sectors.

#### 5. Consumers and the Community

Ensure that consumers and the community are involved at every stage of the funding, research and innovation.

#### 6. Build Culture

Strengthen the research and innovation culture in WA by investing in researchers and innovators to achieve their career aspirations, who can in turn create an environment, through mentorship and collaboration, which supports continued success.

#### 7. Accelerate and Translate

Achieve impact through accelerating the development of innovative ideas into products or services with commercial and/or implementation potential; and enabling the translation of research into practice and policy.

#### 8. Sustainable Long-Term change

Amplify the impact of the FHRI Fund funding by considering sustainability of the supported proposals post the grant period. Take a system change approach to addressing persistent social, economic and behavioural issues affecting health outcomes, acknowledging that long-term change requires a collaborative approach beyond an individual researcher or project.

#### 9. Review and Evaluate

Evaluate the return on investment for all funded programs on a regular basis to maximise the benefits of the FHRI Fund and demonstrate these to stakeholders.
