PRESUMPTION AGAINST <u>BAIL AND PAROLE</u> - COMMONWEALTH TERRORISM OFFENCE COMPARISON TABLE

The following presents a comparison of how each Australian jurisdiction has defined the <u>Commonwealth</u> terrorism offences for their presumptions against bail and parole applying to persons with links to terrorism.

It includes a comparison of the offences defined within the Bail Amendment (Persons Linked to Terrorism) Act 2019 (WA), and the Sentencing Legislation Amendment (Persons with Links to Terrorism) Bill 2021 which provides extensive coverage of the Commonwealth terrorism offences.

In relation to the Bail Amendment (Persons Linked to Terrorism) Act 2019 (WA), and the Sentencing Legislation Amendment (Persons with Links to Terrorism) Bill 2021, the following Commonwealth offences have been expressly excluded.

- Section 104.22 (treatment of photographs and impressions of fingerprints). This offence has been excluded as it relates to the procedures of law enforcement.
- Section 104.27 (offence for contravening a control order) and section 104.27A (offence relating to tracking devices). These offences are excluded because the Western Australia regime will already apply to a person who was subject to a control order in the 10 years prior. It is not necessary to capture the offences of contravening these orders, which may be objectively trivial.
- Section 105.41 (disclosure offences) and section 105.45 (offences of contravening safeguards). The offences relate to disclosure and contravention of Preventative Detention Orders (PDO), and have been excluded as the Western Australia regime is not to apply to persons subject to those orders. This is because PDOs are used for investigative purposes (i.e. interviewing witnesses etc.) and may apply to persons who are not directly associated / involved with terrorism. It is not intended to extend the scheme to contraventions of those orders.
