  - 6. 2021-2022?
- 2. Of those in 1, will the Minister please provide a breakdown of how many were:
  - 1. Occupied; and,
  - 2. Vacant?
- 3. Of those in 2b, will the Minister please provide a breakdown of how many were
  - 1. Returning stock;
  - 2. Non-returning stock; and
  - 3. Other

There were 600 properties added in 2021-2022 including through construction and spot purchase. Some of these properties are not yet reflected in this data as it often takes time for data to be transferred wholly into the Department of Communities' systems, across regional offices.

#### 2.1 - 2.2

Vacancy numbers are always a single point in time number that fluctuates for a range of reasons. Properties may be awaiting acceptance of offers from applicants, undergoing minor maintenance repairs or refurbishment prior to new occupants moving in, or undergoing major refurbishment as part of a redevelopment.

Vacancy information for community housing is unavailable as these properties are managed by external organisations.

Of the 1,927 properties vacant as at 30 June 2022, 1,505 of these properties are undergoing maintenance works before being occupied by applicants on the public housing waiting list. This also includes properties that have been spot purchased which may require refurbishments to be brought up to clean, safe and working standard.

Returning Public Housing properties are vacant and undergoing maintenance, repairs or refurbishments to be made available to an applicant on the waiting list.

Not returning properties include those that have reached their end of life and may have been damaged beyond repair or have been identified for demolition or redevelopment. A proportion of non-returning housing stock is older assets that are beyond their useful life. Difficult decisions have been made on older properties as they reach the end of their useful life, such as Brownlie Towers which consisted of 300 apartments and was demolished in July 2019.
