Answer


(a-c) The proposed amendments to the *Land Administration Act 1997* are a result of extensive and widespread consultation carried out over many years, and multiple governments.


Noting the extent of consultation undertaken, it is not considered to be an appropriate use of government resources to produce an exhaustive itemised list of consultation undertaken.
