

MINISTER FOR CHILD PROTECTION — PORTFOLIOS — STOLEN GOVERNMENT VEHICLES

2828. Mr Z.R.F. Kirkup to the Minister for Child Protection; Women's Interests; Prevention of Family and Domestic Violence; Community Services:

In the past five years and up to the present date, have any government vehicles been reported stolen for each Department, Agency and Government Trading Enterprise (GTEs) in the portfolio of the Minister, and if so:

- (a) how many vehicles were stolen from a government premises;
- (b) how many vehicles were stolen from a residential dwelling or private premises; and
- (c) what was the total value of vehicles stolen in each year?

Ms S.F. McGurk replied:

This answer includes the response for the Department of Communities, from 1 July 2017, and for the former Department for Child Protection and Family Support, Housing Authority, Disability Services Commission and the Communities component of the Department of Local Government and Communities, for the period prior to amalgamation.
