STATE BUDGET, WATER RESOURCES, FUNDING ALLOCATION

178. Mr P.D. Omodei to the Minister assisting the Minister for Minister Assisting the Minister for Water Resources

I refer the Minister to pages 388 and 389 of the 2005-2006 State Budget and ask -

- (a) will the Minister provide a breakdown of the \$79.7 million allocated to water sources as part of the New Work for Water Programs allocation;
- (b) will the Minister provide a breakdown of the \$407.1 million estimated cost of water sources as part of the New Work for Water Programs;
- (c) will the Minister provide a breakdown of the \$178 million estimated cost of capital support costs as part of the New Work for Capital Overheads Support Programs;
- (d) will the minister provide a breakdown of the \$358.5 million estimated total cost of the South West Yarragadee program;
- (e) will the Minister provide details of where the \$396,005 million in borrowings for the capital works program will be sourced from; and
- (f) will the Minister provide details on the interest cost associated with the \$396,005 million in borrowings for the capital works program?

Mr J.C. KOBELKE replied:

- Yes. [See paper 692.] These allocations are reviewed for optimal scope, quality and timing as part of the Corporation's gateway approval process and the attached allocations may change.
- (b) The estimate of \$407.1 million includes \$79.7 million for 2005-2006 as detailed in answer (a) above. The remaining \$327.4 million relates to an estimate for the development of future water sources during the period 2009-2010 to 2014-2015 to meet growth and climate change as part of the Water Corporation's Source Development Plan.
- (c) The \$178 million for the Capital Overheads Support program is a notional estimate of the support costs to deliver the Water Corporation's Capital Program over the next ten years, with \$16 million allocated for 2005-2006. These costs include activities such as program management, procurement management and project co-ordination, with the major component being salary costs.
- (d) The breakdown of the costs for \$358.5 million South West Yarragadee Program at the time of the Water Corporation's capital submission was:

- (e) All the Water Corporation's borrowings are from the Western Australian Treasury Corporation.
- (f) The current average interest rate is 5.87%. Interest rates may fluctuate marginally between now and when the funds are borrowed. Based on the current rate, the full year interest impact of \$396 million new borrowings would be \$23 million.
