ABORIGINAL CULTURAL HERITAGE ACT — REPEAL

471. Mr R.S. LOVE to the Minister for Aboriginal Affairs:

Before I ask the question, I take the opportunity to acknowledge the new member for Rockingham and congratulate her on her election.

Ms R. Saffioti: Have you still got your Liberal hat?

The SPEAKER: Deputy Premier!
