## [Supplementary Information No B37.]

Question: Mr E.S. Ripper asked: Will the minister provide the number of individual councillors who have been subject to a complaint and have been dealt with?

*Answer:* The Department of Local Government, as a part of its general operations, receives complaints about the operations and affairs of local governments. These complaints include, but do not solely relate to the conduct or actions of elected members.

In addition to general complaints, the Department also receives complaints made in accordance with specific legislation such as the *Local Government (Rules of Conduct) Regulations 2007* and the *Public Interest Disclosure Act 2003*.

During the 2011/12 financial year to date the Department has completed 195 complaints. Of those, 82 relate to complaints made against 83 elected members.
