### Mrs L.M. Harvey replied:

- (a) (i) There were 2,854 publicly funded students enrolled at SWIT as at 31 March 2013.
  - (ii) There were 2,584 publicly funded students enrolled at SWIT as at 31 March 2014.
  - (iii) There were 2,743 publicly funded students enrolled at SWIT as at 31 March 2015.

- (c) (i) There were 17 management positions filled at SWIT as at 4 February 2013.
  - (ii) There were 16 management positions filled at SWIT as at 4 February 2014.

  - (ii) The Voluntary Severance Scheme was offered to teaching and management staff in 2014.
  - (iii) The Voluntary Severance Scheme is being offered to teaching and management staff in 2015.
- (e) (i) No teaching and management staff were offered redundancies in 2013.
  - (ii) 3 teaching and management staff were offered redundancies in 2014.
  - (iii) 25 teaching and management staff were offered redundancies in 2015 to date.
