MR F.M. LOGAN (Cockburn — Minister for Corrective Services) [2.47 pm]: I rise under standing order 82A to provide additional information in answer to a question that was put to this house by the member for Dawesville. In his question, the member for Dawesville inferred that the Corruption and Crime Commission report looked into the officer in question and that the officer had let paedophiles access Hungry Jack's restaurants as part of his relationship with the boys.

**The SPEAKER**: Member for North West Central, I call you to order for the second time. I just explained what being on my feet meant but obviously it did not click. What was the comment, member?

Mr D.T. REDMAN: The Minister for Sport and Recreation used an unparliamentary term.

The SPEAKER: Can you tell me what it was?

Mr D.T. REDMAN: It was very loud and it was a four letter word, Mr Speaker.

The SPEAKER: I didn't hear it. I will find out from the Clerk. A grub?

Point of Order

Mr D.T. REDMAN: I have a point of order, Mr Speaker.

**Mr D.T. REDMAN**: Just so I can understand your ruling, I assume that you are accepting the Minister for Sport and Recreation's point to the member for Dawesville that he was in fact a grub as not an unparliamentary term and you did not seek to ask the minister to withdraw it but, in fact, asked whether he would voluntarily withdraw it.

**The SPEAKER**: It is not a point of order. I offered the minister the opportunity to withdraw it, which he did. Are you happy with that?

Mr D.T. Redman: No.

**The SPEAKER**: The member has a problem if you are not happy with that. It is a point of order. I gave him the opportunity—the same as everyone else—to withdraw, as I did today for someone on this side of the house. I did not say "withdraw". I said, "Do you want to withdraw it?" and he did. I cannot see the difference between either side of the house. I will not put up with these points of order that are not proper. You have put your point, member.

**The SPEAKER**: Leader of the Opposition, you are on three calls. I will not have you disrespecting the Chair. The next time, I will not call you but I will name you because of your disrespect for the Chair.
