Hon J. CORNELL: I move-

That the two messages be taken into consideration forthwith, that the conference be agreed to, that the managers for the Council be Hon. J. Nicholson, Hon. H. Stewart, and the mover, and that the conference be held forthwith in Mr. Speaker's room.

I may explain to hon, members that, owing to the President's room being required for other purposes later on, Mr. Speaker has kindly placed his room at the disposal of the managers.

Hon. A. LOVEKIN: I do not wish to take any exception personally to Mr. Stewart being one of the managers, but it has always been a practice that a member representing the majority of those who had really

brought about the conference, should be chosen, together with the Minister. Mr. Stewart voted against the amendment, and I submit that we must have at the conference, representatives of the majority view. I intended to ask that Sir William Lathlain's name be substituted for that of Mr. Stewart, but as we have the right to ask for a ballot I shall adopt that course.

Hon. H. STEWART: I was not approached with regard to the submission of my name as one of the managers, and, from a purely personal point of view, I would rather not be nominated. I take exception to Mr Lovekin's remarks, because on whatever conference I may have sat, I have always considered that I was there to represent the view of the Council, regardless of my personal opinions, or of the direction in which my vote had been cast. Until Mr. Lovekin spoke, I thought that that spirit had actuated every member of this House.

Hon. A. LOVEKIN: On a personal explanation, I assure the House that I had not the slightest idea of easting any reflection on Mr. Stewart.

Hon. H. Stewart: I did not say you did. The reflection was on the Council as a whole.

Hon. A. LOVEKIN: I know that Mr. Stewart, like other hon. members who have sat on conferences as representatives of the council, has always been willing to do his duty to the best of his ability. It is the principle that I had in mind. We must have at the conference those who represent the majority view. That is all I ask for.

Hon. V. HAMERSLEY: I feel that I am partly responsible for this position, and I regret there should be any dispute as to who should represent the Council. It is due to the Acting Leader of the House that as far as possible we shall support his nominees, if he does not depart too far from the usual custom. Mr. Lovekin said the committee should be representative of the majority, but I understand the voting on the division was practically equal. The question was decided on the casting vote of the Chairman.

Members: That was not so.

The PRESIDENT: I suggest that first of all we should carry that portion of Mr. Cornell's motion that it seems the House generally will agree to. That will leave open for discussion the question as to who

shall be our managers. I suggest that the Acting Leader of the House move his motion in the following form:—

That the messages be taken into consideration forthwith, that the conference be agreed to, that the Council be represented by three managers and that the conference be held forthwith in Mr. Speaker's room.

Hon. J. CORNELL: I accept that suggestion and will submit the motion in that form.

Question put and passed.

The PRESIDENT: Now the question arises as to who shall be our managers. I have the names of four hon, members, Mr. Nicholson, Mr. Stewart, Mr. Cornell and Sir William Lathlain.

Hon. J. CORNELL: I am well aware of what has been the established practice of this House, namely, to see that the managers are drawn from the side of the House that has been against the proposal. I do not desire to take away the privileges of hon. members themselves, but there are special considerations attached to the requests for a conference on the two Bills. Although one Bill deals with road boards and the other with municipal councils, the amendments to both are identical. The only object I had in view in naming the three hon. members mentioned, was that, in all circumstances, a spirit of compromise should dominate the proceedings. With Mr. Stewart's consent, I will withdraw his name and accept that of Sir William Lathlain.

Hon. H. STEWART: I have already said that, from my personal point of view, I would be willing to withdraw. I am in the hands of the Council. Without discussing in any way the votes on the Bills, I can mention one specific instance in a previous session when we amended the Land and Income Tax Assessment Act, when there were no managers representative of the Country Party in either House.

The PRESIDENT: The discussion is irrelevant. If any hon member wishes to make a personal explanation, I am willing to hear it.

Hon. Sir WILLIAM LATHLAIN: I desire that my name be withdrawn from the nominations for managers.

The PRESIDENT: I have now three nominations.

Hon. G. W. MILES: I am pleased that Sir William Lathlain has withdrawn. I think the Deputy Leader of the House did the right thing by nominating one representative of municipalities and one of road boards. As one who voted for insisting on the amendment in opposition to Mr. Stewart, I hope the names mentioned will be agreed to.

Question put and passed, and a message accordingly returned to the Assembly.
