# 144A. Licensing and registration scheme for strata managers and agents, employees and contractors of strata managers

- (1) The regulations may provide for a scheme for
  - (a) the licensing, regulation and supervision of strata managers; and
  - (b) the registration, regulation and supervision of agents, employees and contractors of strata managers.
- (2) Without limitation, regulations made for the purposes of this section may provide for or regulate the following
  - (a) the administration of the scheme:

- (b) the procedure to be followed in respect of applications;
- (c) the criteria for the grant of a licence or registration;
- (d) the grant, variation, renewal, transfer, surrender, suspension and cancellation of licences and registration;
- (e) exemptions under the scheme;
- (f) the creation of offences and the imposition of penalties not exceeding a fine of \$3,000.

- (1) The regulations may provide for a scheme for
  - (a) the licensing, regulation and supervision of strata managers; and

- (2) Regulations for the purposes of this section may provide that a contravention of a specified provision of Part 9 is an offence and may provide for the offence to be punishable on conviction by a penalty not exceeding a fine of \$3 000.
- (3) Without limitation, regulations for the purposes of this section may provide for or regulate the following
  - (a) the designation of a person to be the licensing authority for the scheme:
  - (b) the functions of the licensing authority in connection with the scheme;
  - (c) an exemption for volunteer strata managers from any requirement to hold a licence under the scheme;
  - (d) applications for or in relation to licences including
    - (i) the manner in which applications are to be dealt with; and
    - (ii) requirements as to the training, qualifications and experience of applicants; and
    - (iii) requirements for applicants to demonstrate good character, personal probity and financial probity; and
    - (iv) requirements for applicants to produce information relevant to an application;
  - (e) the grant, variation, renewal, transfer, surrender, suspension and cancellation of licences;
  - (f) the duration of licences;
  - (g) the imposition of conditions on licences, the kinds of conditions that can be imposed and the consequences of failing to comply with conditions;
  - (h) the conduct of licensed strata managers in relation to their functions under this Part, including
    - (i) requirements to open and maintain trust accounts, and

- requirements as to the use and operation of those trust accounts; and
- (ii) requirements to have accounts audited, and to submit audit certificates to the licensing authority; and
- (iii) requirements to furnish documents and information to the licensing authority;
- (i) the supervision by the licensing authority of licensed strata managers in relation to their functions under this Part, including
  - (i) power for the licensing authority to require persons to produce records, documents and information relevant to the activities of a licensed strata manager;
  - (ii) power for the licensing authority to enter onto premises and to inspect and take copies of records, documents and information;
  - (iii) power for the licensing authority to commence prosecutions for contraventions of the regulations or conditions of licences;
- (j) the appointment of persons authorised to act on behalf of the licensing authority for the purposes of the scheme.
