## **Anzac Day Amendment Bill (No. 2) 2015**

**A Bill for**

**An Act to amend the *Anzac Day Act 1960*.**

The Parliament of Western Australia enacts as follows:

**s. 1**

1   **1.       Short title**

2           This is the *Anzac Day Amendment Act (No. 2) 2015*.

3   **2.       Commencement**

4           This Act comes into operation as follows —

5           (a)   sections 1 and 2 — on the day on which this Act  
6                receives the Royal Assent;

7           (b)   the rest of the Act — when the *Anzac Day Amendment*  
8                *Act 2015* section 3 comes into operation.

9   **3.       Act amended**

10          This Act amends the *Anzac Day Act 1960*.

11   **4.       Section 5 amended**

12          (1)   Delete section 5(1)(b) and insert:

14               (b)   pay to the Trust —

15                   (i)   an amount equal to 5% of the price of a  
16                        prescribed admission ticket for the event  
17                        multiplied by the number of persons  
18                        who attended the event; or

19                   (ii)  if the Minister has approved an  
20                        alternative amount under  
21                        section 10A(2) — that alternative  
22                        amount.

24          (2)   Delete section 5(3).

1 **5. Section 7 amended**

2 Delete section 7(1)(b) and insert:

4 (b) pay to the Trust —

5 (i) an amount equal to 5% of the price of a  
6 prescribed admission ticket for the event  
7 multiplied by the number of persons  
8 who attended the event; or

9 (ii) if the Minister has approved an  
10 alternative amount under  
11 section 10A(2) — that alternative  
12 amount.

14 **6. Section 10A inserted**

15 Before section 10 insert:

16

17 **10A. Approved alternative amounts to be paid to Trust**

18 (1) A person may, not less than 30 days before an event  
19 held on Anzac Day, apply in writing to the Minister for  
20 approval of an alternative amount to be paid to the  
21 Trust under section 5(1)(b) or 7(1)(b).

22 (2) The Minister may, by notice in writing to the applicant  
23 before the event, approve the alternative amount in  
24 relation to the event.

25 (3) The alternative amount may be a fixed amount or an  
26 amount determined in accordance with a formula  
27 specified by the Minister in the notice.
