**An Act to amend the *Child Support (Adoption of Laws) Act 1990*.**

The Parliament of Western Australia enacts as follows:

**s. 1**

1   **1.     Short title**

2           This is the *Child Support (Adoption of Laws) Amendment*  
3           *Act 2009*.

4   **2.     Commencement**

5           This Act comes into operation as follows —

- 6           (a)   sections 1 and 2 — on the day on which this Act  
7           receives the Royal Assent;  
8           (b)   the rest of the Act on the day after that day.

9   **3.     Act amended**

10          This Act amends the *Child Support (Adoption of Laws)*  
11          *Act 1990*.

12   **4.     Purpose of Act**

13          The purpose of this Act is to provide that the adoption by the  
14          *Child Support (Adoption of Laws) Act 1990* of —
