A Bill for

An Act to amend various Acts as a consequence of the Commonwealth enacting the *Corporations Act 2001* and to make other minor amendments relating to the regulation of bodies corporate.

The Parliament of Western Australia enacts as follows:

Part 1 — Preliminary

1. Short title

This Act may be cited as the *Corporations (Consequential Amendments) Act (No. 2) 2001*.

5 **2. Commencement**

This Act is deemed to have come into operation immediately after the *Corporations Act 2001* of the Commonwealth came into operation.
