A Bill for

***An Act to amend the Agriculture and Related Resources Protection
Act 1976.***

The Parliament of Western Australia enacts as follows:

1. Short title

This is the *Agriculture and Related Resources Protection
Amendment Act 2005*.

2. Commencement

This Act comes into operation on the day on which it receives the Royal Assent.

3. The Act amended

10 **4. Section 58 amended**

Section 58(1)(b) and (c) are each amended by deleting “zonal”.

5. Section 60 amended

(1) Section 60(1) is amended by deleting “1976” and inserting instead —

15 “ 2006 ”.

(2) Section 60(2) is amended by deleting “general”.

(3) Section 60(3) to (5) are repealed and the following subsections are inserted instead —

“

20 (3) The Protection Board, with the approval of the Minister, may, by notice published in the *Gazette* on or before the 30 June immediately preceding a financial year to which this section applies, impose in respect of that financial year rates in respect of land held under
25 pastoral lease.

(4) A rate imposed under subsection (3) —

(a) must be imposed upon the unimproved value of land to which the rate applies; and

- (b) must not be at a rate exceeding 10 cents in the dollar of the unimproved value of land.
- (5) All rates imposed under subsection (3) in respect of land that is in the same zone must be at the same rate.
- 5 (6) All rates imposed under subsection (3) in respect of land that is not in a zone must be at the same rate.
- (7) Despite the amendments made by the *Agriculture and Related Resources Protection Amendment Act 2005*, this Act, as in force immediately before the day on
10 which that Act comes into operation, continues to apply in relation to a rate payable for a financial year commencing before 1 July 2006.

6. Section 61 amended

15 Section 61(1) and (2) are each amended by deleting “zonal”.

7. Section 63 amended

Section 63(2) is amended as follows:

- (a) by deleting “general”;
- (b) by deleting “zonal”.
