THURSDAY, 20 NOVEMBER 2014

1. Meeting of Assembly

The Assembly met at 9.00 a.m. pursuant to adjournment.

The Speaker took the Chair.

Prayers were read.

2. Petitions

Bus Services in Mirrabooka – Ms J.M. Freeman presented a petition from 48 persons requesting that the Legislative Assembly looks at bus services in Mirrabooka to ensure that they meet growing demand (P. 196).

Genetically Modified Crops Free Areas Act 2003 – Mr A. Krsticevic presented a petition from 20 persons requesting that the Legislative Assembly calls for an independent review of the *Genetically Modified Crops Free Areas Act 2003* by a parliamentary committee, and also that it supports GM-free farming and urges the Government to introduce farmer protection legislation to compensate farmers who suffer economic loss due to GM contamination (P. 197).
