#### 5. Petitions

Perth Freight Link – Ms S. McGurk presented a petition from 3523 persons asking the Legislative Assembly to call on the Barnett Government to stop the Perth Freight Link and use the money to improve the rail links to the existing harbour and to increase freight on rail, and to look at real freight alternatives for the future (P. 322).

Equal Opportunity Act 1984 – Ms L.L. Baker presented a petition from 115 persons asking the Legislative Assembly to remove the loophole in section 73 of the *Equal Opportunity Act 1984* that allows religious school to discriminate on the basis of sexuality and gender history (P. 323).

Wharf Street Railway Crossing – Mr W.J. Johnston presented a petition from 32 persons asking the Legislative Assembly to call on the Barnett Government to do something about the Wharf Street railway crossing in Queens Park which is dangerous and dysfunctional and needs to be improved to ease congestion (P. 324).

Seniors in Western Australia – Mr W.J. Johnston presented a petition from 25 persons asking the Legislative Assembly to call on the Barnett Government to look after Seniors in the community and provide for a fairer budget as the State's most vulnerable citizens are paying the penalty (P. 328).
