Can the Minister advise the attrition rates for St John Ambulance volunteers for the years 2012–2013 and 2013–2014?

3115. Ms M.M. Quirk to the Treasurer:

I refer to the Minister's announcement to conduct a review of concessions and ask:

- (a) who is conducting that review;
- (b) are there terms of reference for the review, and if so, what are those terms of reference:
- (c) is there a target amount of savings which the Minister wants to achieve;
- (d) when will the review be concluded; and
- (e) is it intended to consult stakeholders or representatives of groups likely to be impacted by any changes to concessions?

3116. Ms M.M. Quirk to the Premier:

Can the Premier list all the committees convened by the Department of Premier and Cabinet in which persons outside the public service participate (irrespective of whether they receive sitting fees):

- (a) for each of those committees please list the membership; and
- (b) for each of those committees please list their title and terms of reference?

3117. Ms M.M. Quirk to the Minister for Emergency Services:

- (1) Can the Minister list the Department of Emergency Services Capital works program for the next ten years?
- (2) Can the Minister list the career fire stations planned to be built within the next five years and the estimated date of completion of each?

3118. Ms M.M. Quirk to the Minister for Emergency Services:

- (1) Can the Minister advise how much funding was allocated in the 2013-2014 financial year to fund the Juvenile and Family Fire Awareness Program (JAFFA) anti arson program?
- (2) Can the Minister also advise how much funding is currently allocated in the 2014-15 financial year to fund the JAFFA anti-arson program?

3119. Ms M.M. Quirk to the Premier:

Will the Premier list new artworks purchased by the Department of the Premier and Cabinet from 30 June 2013 to 20 May 2014 including:

- (a) the price of each artwork;
- (b) from where the artwork was purchased;
- (c) who authorised the purchase of each; and
- (d) the current location of each?

3120. Ms M.M. Quirk to the Parliamentary Secretary representing the Minister for Commerce:

I refer to a report on prepaid funerals currently with government, and ask, what measures is the Minister intending to take to protect the funds held for prepaid funerals:

- (a) if the Minister intends to take measures, what is the time frame; and
- (b) if no measures are to be taken, why not?

3121. Ms M.M. Quirk to the Minister for Health:

I refer to discussions about transferring responsibility for Home and Community Care back to the Commonwealth government and I ask what is the reason for these deliberations occurring and what stage are they at?

3122. Ms M.M. Quirk to the Minister for Heritage:

Can the Minister please advise whether the Heritage Council has negotiated and/or executed any heritage agreements with any of the site owners at Elizabeth Quay?

3123. Ms M.M. Quirk to the Minister for Transport:

Can the Minister advise when the widening of Reid Highway between Erindale Road and Duffy Road will commence and when is it expected that the work will be completed?

3124. Ms M.M. Quirk to the Minister for Emergency Services:

Can the Minister advise the following in relation to fire hydrants:

- (a) what is the total number of fire hydrants which the Water Corporation now has responsibility for;
- (b) since taking over the maintenance of fire hydrants from the Department of Fire and Emergency Services has the Water Corporation conducted a State wide audit/inspection of all fire hydrants to ensure their location is accurate, and if not, what areas/ towns have not been audited;
- (c) can the Minister advise how many hydrants currently require repair;
- (d) what is the average waiting time for these repairs to be finalized; and
- (e) are there key performance indicators for how often hydrants are inspected and maintenance undertaken, and if so, what are they?

3125. Ms M.M. Quirk to the Minister for Water:

Can the Minister advise the following in relation to fire hydrants:

- (a) what is the total number of fire hydrants which the Water Corporation now has responsibility for;
- (b) since taking over the maintenance of fire hydrants from the Department of Fire and Emergency Services has the Water Corporation conducted a State wide audit/inspection of all fire hydrants to ensure their location is accurate, and if not, what areas/ towns have not been audited;
- (c) can the Minister advise how many hydrants currently require repair;
- (d) what is the average waiting time for these repairs to be finalized; and
- (e) are there key performance indicators for how often hydrants are inspected and maintenance undertaken, and if so, what are they?

3126. Ms M.M. Quirk to the Minister for Emergency Services:

I refer to the *Parkerville Stoneville Mt Helena Bushfire Review* which recommended that the Department of Fire and Emergency Services "...should increase and maintain urban interface bushfire skills and expertise. Appointments to senior roles within the agency should include people with experience and credibility in bushfire fire fighting and management", and I ask, what measures have been taken to ensure that these concerns identified by the review have been addressed?

3127. Ms M.M. Quirk to the Minister for Emergency Services:

I refer to the *Parkerville Stoneville Mt Helena Bushfire Review* which recommended that radio infrastructure in the Perth Hills should be reviewed to assess whether it is practicable for radio and/or mobile phone coverage to be improved to achieve better coverage across the area and ask, can the Minister advise what actions have been taken to ameliorate the communication black outs identified in the review?

3128. Ms M.M. Quirk to the Minister for Emergency Services:

I refer to the *Parkerville Stoneville Mt Helena Bushfire Review* which recommended automatic vehicle location technology should be adopted to enable a better appreciation of the deployment and location of appliances at an incident, in order to increase situational awareness and I ask:

- (a) at what stage is the installation of this technology in vehicles; and
- (b) when do you anticipate that the total fleet will have this technology fitted?

3129. Ms M.M. Quirk to the Minister for Emergency Services:

I refer to the *Parkerville Stoneville Mt Helena Bushfire Review* which recommended that the Department of Fire and Emergency Services, in consultation with bushfire volunteers should develop a procedure for the controlled entry and exit of volunteers to the fire ground and I ask, what steps have been taken to address this impediment to brigades reaching the fire ground?

3130. Ms M.M. Quirk to the Minister for Emergency Services:

I refer to the *Parkerville Stoneville Mt Helena Bushfire Review* which recommended that every effort should be made to enhance the ability of communications personnel to cope with fast moving and time critical fire events by providing and maintaining: ongoing extensive communications training; advanced vehicle capability for clear communication within areas of radio coverage dead spots; ability to receive Air intelligence live streaming; and, all Incident Control Vehicles with access to DFES Information Technology Systems, and I ask, how have these major issues been addressed in preparation for this fire season?

3131. Ms M.M. Quirk to the Minister for Emergency Services:

I refer to the *Parkerville Stoneville Mt Helena Bushfire Review* which notes reports of unknown 'outside' interference across the uncontrolled radio network and insufficiencies in the fire ground radio network added to the communication issues experienced on the day. An investigation of the interference recordings by Department of Fire and Emergency Services (DFES) Communications Branch found the interference was caused by deliberate transmissions from an unknown, unauthorised user with a radio set that transmitted on DFES channel 238, and I ask:

- (a) what measures exist for the investigation and prosecution of unauthorised users in such circumstances:
- (b) what offences are such persons allegedly committing; and
- (c) was there evidence that these unauthorised transmissions were from a child or children?

3132. Ms M.M. Quirk to the Minister for Emergency Services:

I refer to the *Parkerville Stoneville Mt Helena Bushfire Review* which recommends that a Restricted Access Permit system for the entry/ re-entry of residents should be finalised, and I ask, has this been actioned and what is the proposed process for the allocation and issue of such permits?

3133. Ms M.M. Quirk to the Minister for Emergency Services:

I refer to the *Parkerville Stoneville Mt Helena Bushfire Review* which found inconsistent naming conventions added to misunderstandings and the chaos. Naming conventions require greater attention during the pre-planning phase of the event and that task force that was formed at and deployed from the Kiara fire station was referred to by six different names in the first two hours of its deployment and during this time there was also a reference to Kiara pump and light tanker being a task force which increased confusion, and I ask, how is this fundamental problem being addressed to ensure that similar problems do not arise in future incidents?

3134. Ms M.M. Quirk to the Minister for Emergency Services:

I refer to the *Parkerville Stoneville Mt Helena Bushfire Review* and the observation that some families were upset at finding out about damage to their homes through the news and social media before being formally advised, while others felt that the waiting time to find out what happened to their homes was too long, and I ask, what refinements of current procedures are being implemented to avoid this occurring at future incidents?

3135. Ms M.M. Quirk to the Minister for Tourism:

- (1) Can the Minister for Tourism advise the total value of incentives given to BGC and the Starwood hotel group for the construction of a hotel on the old Fire and Emergency Service Authority house site?
- (2) What are the components and amounts of concessions making up that total?

3136. Dr A.D. Buti to the Minister representing the Attorney General:

I refer to the Law Reform Commission of Western Australia *Enhancing Laws Concerning Family and Domestic Violence Final Report* and ask when will the State Government will be providing its official response to the report?

3137. Dr A.D. Buti to the Parliamentary Secretary representing the Minister for Mental Health:

I refer to the Western Australian Auditor General's Report entitled *The Implementation and Initial Outcomes of the Suicide Prevention Strategy Report 7: May 2014* and ask what measures has the Western Australian Government made in response to the Auditor General's recommendation on page 8 of the report?

3138. Mr P. Papalia to the Minister for Corrective Services:

I refer to Question on Notice No. 1832 of 18 February 2014, and ask for each calendar year from 2008 to 2013, of those offenders who entered prison for fine default alone how many (in each calendar year) were both Aboriginal and female?

3139. Mr R.H. Cook to the Minister for Transport:

I refer to the Main Roads Western Australia's *Road Safety Audit Corrective Action Report*, dated 25 November 2012, specifically recommendations 7.1 through 7.13 inclusive, and I ask:

- (a) of these recommendations, which ones have been implemented;
- (b) of the recommendations that have been implemented, on which date did each one occur; and
- (c) for each of the recommendations that are yet to be implemented, what plans are in place for them to be completed?

3140. Ms M.M. Quirk to the Minister for Health:

I refer to the provision of interpreters for the Fiona Stanley Hospital and ask:

- (a) are language services (encompassing the provision of interpreters) contracted out:
 - (i) if not, why not; and
 - (ii) if so, when were tenders advertised;
- (b) have tenders closed, and if so, how many tenders were received;
- (c) if the tender was granted, to which company was the tender contracted; and
- (d) what was the value of the contract?

3141. Mr F.M. Logan to the Minister for Housing:

Minister, I draw your attention to the Department of Housing apartment development situated on the corner of Signal Terrace and Linkage Avenue, Cockburn Central and I ask:

- in this mixed residential development, were apartments leased out, either through the Department or an agency on a short-term basis to Chevron or other oil/gas or mining companies and if so how many;
- (b) were the apartments referred to in (a) being used by resource company employees/contractors as intermediate accommodation to and from site or as temporary accommodation whilst undertaking inductions prior to departure to site or employment; and
- what is the contractual status of the apartments referred to in (a) above currently (e.g. are they still owned by the Department of Housing and leased out to resource companies or others; or sold)?

3142. Mr F.M. Logan to the Minister for Housing:

- (1) I refer to the total capacity and value of land vested in the Department of Housing, the Housing Commission and other organisations within the Housing Portfolio, that holds, sells or leases land and I ask what is/are:
 - (a) the total volume of in-globo land held or vested in the above organisations;
 - (b) the locations where the in-globo land is held; and
 - (c) the approximate value of the in-globo land?
- (2) With reference to land developments, what is/are:
 - (a) the yield of blocks from land developments undertaken as Joint-Ventures by the above organisations;

- (b) the locations where are the blocks are held; and
- (c) the approximate value of the blocks held?
- (3) With reference to developed blocks, what is/are:
 - (a) the total volume of developed blocks held or vested in the above organisations;
 - (b) the locations where the blocks are held; and
 - (c) the approximate value of the blocks held?
- (4) With reference to empty blocks, what is/are:
 - (a) the total number empty lots and blocks held or vested in the above organisations;
 - (b) the locations where the blocks or lots are held; and
 - (c) the approximate values of the blocks and lots held?
- (5) If there is any other land holdings not referred to in the above questions, could the Minster please provide an overview of the volume of such land held/vested, the locations of such land and the approximate value?

3143. Mr M.P. Murray to the Minister for Housing:

I refer to the Department of Housing (Housing) and properties and/or vacant lots located in Collie, and ask:

- (a) how many Housing properties exist in Collie;
- (b) what are the bedroom configurations of these properties; and
- (c) how many of these Housing properties are currently untenanted?
