THURSDAY, 22 OCTOBER 2015

1. Meeting of Assembly

The Assembly met at 9.00 a.m. pursuant to adjournment. The Speaker took the Chair.

2. Petitions

Perth Freight Link: Roe Highway Extension – Mr P.C. Tinley presented a petition from 30 persons requesting that the Legislative Assembly calls on the Barnett Government to reverse the decision to allow the Roe 8 Highway (eastern end of the Perth Freight Link) to go ahead and to support requests by the residents of the City of Cockburn, the sons and daughters of the AWAS women and the RSL City of Cockburn Sub branch to preserve, and not destroy this site (P. 307).

Perth Freight Link: Roe Highway Extension – Mr P.C. Tinley presented a petition from 175 persons requesting the Legislative Assembly to call on the Barnett Government to reverse their decision to allow the Roe Highway Extension (eastern end of the Perth Freight Link) to go ahead and to allocate the funding awarded to this project to other alternative solutions to freight transfer issues (P. 308).

Hospital Parking for Justices of the Peace – Mr P.C. Tinley presented a petition from 229 persons requesting the Legislative Assembly to call on the Barnett Government to reverse the decision to charge Justices of the Peace to park at Fiona Stanley Hospital when attending to their duties and ensure that Justices of the Peace are provided with adequate car bays at all hospitals in the State, without charge to enable them to assist staff, families and patients (P. 309).
