Here is my response to your question 1. I have seen quite a few "classical" twinning programs where the partnerships between universities are limited to one way student movement. International students from partner universities move to Australian partner universities after completing a the agreed credits. Our partnerships encompass teaching, research and industry engagement. We develop student mobility projects that enables Curtin students to have both learning and research experience at a partner university.
