Please find the following corrections from Western Australia Police to the transcript of evidence provided to the Standing Committee on Estimates and Financial Operations on 5 June 2012.

Page 13

Paragraph 12 – Mr Lord – You would be looking at around \$10 000 to \$15 000.

This comment refers to the normal cost of fitting out a standard police vehicle. Mr Lord when providing this response has indicated costs from an asset related perspective that did not include TADIS (in car computer) technology costs which would have escalated the amount quoted.

It should be noted that arising from this particular point of inquiry, Supplementary Information No C6 was requested in which the exact figures relating to fitting out a standard police vehicle was requested and will be provided.
