The CUP has delivered an additional 349 bays to date with further capacity to be delivered at Bassendean station (211 bays) and Guildford station (350 bays). The provision of the bays at Guildford station will be subject to Heritage conditions.

In 2017-18 the funding is not yet allocated to any particular project.

Question No 13: Hon Ken Travers MLC asked - I refer to Budget Paper No 2, Volume 2, at page 826, and ask-

- a) What modelling has been done on the impact on the move of year seven students to high school will have on transport services on schools?
- b) Which schools will require additional services?
- c) How many additional bus services will they require?
- d) Will any of the affected high schools require new embayments or other infrastructure to cater for additional bus services?
- e) How much has been allocated in the State Budget for the additional infrastructure?

Answer:

- a) In 2011, for the Perth metropolitan area Transperth sought information from schools about anticipated Year 7 enrolments (for 2015) and combined this with an analysis of SmartRider data usage (based on Year 8 take up rates) and existing bus loadings to determine the likely number of additional buses that would be required to cater for the transition of Year 7 students into high school. For regional towns, the PTA used known existing bus patterns and anticipated school enrolments to determine bus needs.
- b) While intake will vary across schools, Transperth currently anticipates that Churchlands, Canning Vale, Rossmoyne and Baldivis Senior High Schools will require additional services in 2015. Services to other schools will be allocated as demand dictates. For schools in regional areas, it is anticipated that the following towns will be allocated additional buses;
 - Albany;
 - Bunbury;
 - Busselton:
 - Carnarvon;
 - Esperance;
 - Geraldton;
 - Kalgoorlie;
 - Karratha;
 - Kununurra;
 - Broome.
- c) Transperth has allocated an additional 36 buses to cater for the increased demand in the Perth metropolitan area and an additional 10 buses for regional town services.

- e) In the state budget, \$24.3m has been allocated for the additional 46 buses required for the move of year 7 students to high school.
