Question No A1 Hon L Ravlich asked for a list of main projects in the Pilbara, their construction time frames, workforce during construction, operational time frame and royalty expectations?

Question No A2 Hon K Travers asked if shipping services to the North West were to be discontinued, would it have an impact on the construction costs of housing generally across the North West?

Answer: The shipping service to the North West of the State has not been discontinued. On December 18 the Government announced that it would contract a major Norwegian shipping company, Jebsens to provide shipping services to the North West of the State. This will help keep freight costs into remote regions low and also help make roads safer by removing a number of trucks from the road network.

Question No A3 Hon L Ravlich asked for an overview of the percentage of government housing, mining housing and private housing in the Pilbara?

Answer: The specifics of this question are planned for identification in the Housing Study currently being jointly undertaken by the Pilbara Development Commission (PDC) and the Department of Housing. Government housing (GROH and Homeswest) figures are shown below and are included in the PDC's quarterly Housing and Land Snapshot publication available on its website.

The Town of Port Hedland has estimated total ratable dwellings at 5500 while Shire of Roebourne has indicated they have 6000 ratable dwellings. These figures are based on ABS statistics from 2006, new rates licences and local methods of recording.


Unfortunately we are unable to determine at this stage the percentage of commercially owned residential dwellings until the Housing Study is completed.

Question No A4 Hon K Travers asked for any predictions on what the major towns in the Pilbara are expected to grow by in the next 10 years?

Answer: The WA Planning Commission has adopted the Pilbara Industry's Community Council Population Projections figures in planning for the region. The graph below illustrates the expected growth from 41,000 in 2006 to above 50,000 in 2015 based on the minimum expected population as a direct result of major planned and potential resource projects in the region as of 2008. The reference to a doubling of population may refer to the expected increase in resource related employment from 15,000 in 2006 to an expected 30,000 in 2015 plus the impact of the Pilbara Cities blueprint.

Question No A5 Hon K Travers asked for a breakdown of the \$300million committed by this government to revitalise the Pilbara?

Answer: The \$300 million Pilbara Revitalisation Plan is being funded through the Western Australian State Government's Royalties for Regions program over four years. The funding included an allocation of \$120 million in the 2008-09 financial year, with the remainder to be spent in the out years.

The Pilbara Revitalisation Plan has allowed the implementation of core projects identified in regional community development plans such as the Karratha 2020 Vision, Newman Tomorrow, Hedland's Future Today, the Shire of Ashburton Strategic Plan and the Pilbara Plan. Current projects which have been allocated funding include:

- Tom Price Town Centre Revitalisation \$10million
- Onslow Sporting and Multi Purpose Precinct \$7million
- Newman Town Centre Redevelopment and Land Release incorporating Newman Cultural Precinct -\$20million
- Karratha Learning and Leisure Precinct \$20.3million
- Rejuvenation of the Port Hedland JD Hardie Centre and Youth Zone \$2.6million
- South Hedland Multi Purpose Recreation Centre \$4.12million
- Upgrade of public amenities and implementation of crime and safety prevention initiatives in Port Hedland/South Hedland - \$10.78million
- Pilbara Water Projects \$2.5million
- Pilbara Underground Power Program \$100million
- Karratha Service Workers Accommodation \$30.4million
- Pilbara Health Initiative \$35,464million

Question No A8 Hon L Behjat requested details of the October 2008 Pilbara Women's Conference in relations to the expenditure of the project?

Answer: The Pilbara Women's Conference had a budget of \$108,000, of which the Pilbara Development Commission provided \$60,000.

A Sponsorship Prospectus attracted a total of \$37,000 from BHP Billiton, Rio Tinto, Woodside, North West Alliance and Port Hedland Port Authority. The remaining budget was covered by funds generated through delegate registrations, Conference events ticket sales and stall holder fees.
