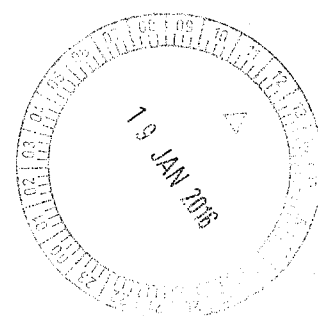

Department of Corrective Services

The following questions (B1 – B14) have been answered based on financial year, rather than calendar year for the purposes of adhering to Department of Corrective Services' (the Department's) reporting standards, which includes the Department's Annual Report.

Five years of data, including prison census data as at 30 June and Daily Average Population (DAP) are provided to assist with making comparisons over time. The DAP provides a better measure of yearly prison population, as census counts are for the nominated date only and are not representative of any given day.





Answer:





The Committee will:


- identify and promote opportunities to enhance the welfare and wellbeing of women in contact with the corrections system;

- identify options to make community corrections more effective and strike an appropriate balance between punitiveness, community safety, and rehabilitation;
- ensure continuous evaluation and improvement of programs and services delivered to women and their families; and
- raise awareness about the complexity of social, economic and individual factors that are associated with female offending.





There were 10 instances of non-compliance reported by the Office of the Auditor General. Further investigation of these indicated that only two were in fact non-compliant.


For the remaining eight, competitive quotes were sought where required if they were not covered by a Common Use Arrangement or an Agency contract.

1) Provide a general summary of what the 31 matters raised in the Auditor General's qualified audit are, what your response is and when you expect to have them in place (Page 23).

Answer:

In summary the 31 Office of the Auditor General (Auditor General) recommendations relate to:

Assets

12 recommendations were made for improving and maintaining the Department's fixed asset register requiring the Department to:

- Conduct a physical stocktake of all of its fixed assets;
- Review its asset management policies and procedures, including the review of the asset depreciation rates; and
- Update the Department's Portable and Attractive item register.

Inventory

Four recommendations were made for improving the recording of the Department's inventory requiring the Department to conduct a physical stocktake of its inventory items, including the pharmaceuticals and prison industries.

Payroll

Six recommendations were made for improving the Department's payroll controls. The recommendations were primarily associated with timely processing of employee cessation checklists, payroll certification statements and follow up notifications of overpaid employees. Recommendations also included the need for the Department to manage its leave liability, and ensure the roster books and timesheets are signed and reviewed.

Financial

Four recommendations were made in relation to:

- Establishing policies and procedures dealing with support action requirements to protect threatened Prison Officers;
- Establishing clearer guidelines to all credit card holders prohibiting the use of personal reward cards;
- Ensuring segregation of duties is maintained during the collection and banking of monies; and
- Reviewing the accounting treatment for cash held on behalf of prisoners and the manner in which Royalties for Region funding is disclosed.

Procurement

Three recommendations were made for the Department to review the current procurement practices to ensure:


- Compliance with State Supply Commission policies and best practice standards;
- All contract variations are approved with appropriate level of documentation; and
- Controls are in place to ensure expenditure is in line with the contract.

General

Two recommendations were made for the Department to ensure it has an effective internal audit function, and to complete and endorse a Risk Management framework.

In response to the 31 Auditor General recommendations, the Department has:

- Accepted and supported the majority of the recommendation made by the Auditor General.
- Progressed several of the recommendations during the audit and Auditor General opinion being released.
- Initiated a plan of action to systematically address the issues raised by the Auditor General in advance of the 2015-16 audit process with:
 - Each finding being assigned an owner with responsibility for implementing corrective measures and allocating the required resources to address the issues; and
 - The aim to complete the various elements of the action plan at varying dates between 30 June 2015 and 31 December 2016.
- Implemented a procedure whereby the Department's Performance, Assurance, Risk and Audit Committee review the plan of action progress report, and provide direction as required at each meeting.
- Embarked on an asset and inventory stocktake project that is anticipated to be completed by 30 June 2016.





1) In relation to the Foetal Alcohol Spectrum Disorder (FASD) project at Banksia Hill: (Page 26-27).

a) When did the project at Banksia Hill commence?

Answer:

The project at Banksia Hill was commenced in May 2015 by the Telethon Kids Institute.

b) How long is that project going to run for?

Answer:

It is anticipated that the Telethon Kids Institute study will take 12 to 18 months to complete.

c) Is it only funded by Telethon Kids Institute or is there Government funding in that?

Telethon Kids Institute was awarded funding from the National Health and Medical Research Council.

d) What do you expect to happen with the data that they will collect?

Answer:

The research project is to develop and test a FASD screening tool suitable for young people in detention in Australia. The findings from the research will inform case management for young people with FASD, and the researchers will also develop a FASD training package for Department of Corrective Services staff.

e) Can you tell me how much the Department has contributed to the funding, what the quantum is?

Answer:

The Telethon Kids Institute Project is facilitated by Commonwealth funding, and the Department has not contributed any funding.






