- Rail infrastructure changes at East Perth station.

Answer: A preliminary business case was undertaken by the PTA in 2010 to understand potential costs and benefits of the project.

The PTA does not record in any database reasons why an infringement notice is withdrawn and therefore to provide exact figures would require individual investigation of every parking ticket withdrawn for the period in question.

Undertaking such a significant task is considered to be an unreasonable use of public resources. Nevertheless the majority of reasons are:

- Vehicle SmartParker registration issues i.e. vehicle not registered, incorrect registration or incorrect vehicle activation where a customer has multiple vehicles registered.
- Paper ticket issues which include ticket falling from the dashboard of a vehicle, placing ticket upside down on dashboard or person taking ticket with them.
- People forgetting to tag on for SmartParker, noting that if this is a one off occurrence, infringements are withdrawn.
- User error i.e. people not using SmartParker machines correctly such as swiping SmardRider card too quickly.
- Miscellaneous reasons such as people forgetting to display their ACROD permit.

17) Do contracts issued by the PTA ever include a provision that requires the Contractor must comply with the provisions of all relevant workplace agreements or awards?

Answer: Yes.

18) If yes to (17),

a) how does the Department ensure that the tendered price is sufficient to ensure that this can occur;

Answer: The price offered by any supplier is a commercial decision that each supplier makes and is based on many factors. Where the PTA considers that a price is too low and not commercially viable for any reason including whether the contractor has the capacity to comply with the provisions of all relevant workplace agreements or awards, the PTA may seek clarification from that supplier.

b) how does the Department ensure that the Contractor complies with this provision; and

Answer: The PTA ensures that the Contractor complies with this provision by conducting audits to ensure that the contract terms are being complied with and the PTA has the right to investigate any complaints or suspected misconduct.

c) are contractors able to use Labour Hire Companies to avoid this provision?

Answer: No, Contractors cannot use labour hire companies to avoid the contractual provision ensuring minimum terms and conditions of employment. PTA contracts allow a contractor to use a subcontractor and it is a required term of any subcontract that a subcontractor must be engaged on terms that meet the minimum standards and conditions of employment for the relevant industry. Failure to engage a subcontractor on these terms would place the Contractor in breach of the Contract.

- 19) Who is responsible for constructing and funding rail links to;
 - a) any new container port in Cockburn Sound; and
 - b) the existing inner harbour container port?

Answer: The State Government and/or the private sector is responsible for constructing and funding rail connections dependent on the commercial viability of the link.

Answer: Unpaid boardings are estimated for the train system as a whole and not by line due to the lack of ticketing data.

22) When is it expected the new ferry terminal in Elizabeth Quay will open to the public?

Answer: The date for commencement of ferry services to the Elizabeth Quay ferry terminal is being determined by the Metropolitan Redevelopment Authority. Services will continue to operate from Barrack Street jetty until this time.
