(iii) Is that surcharge authorised by a legislative Instrument, for example, by regulations?





# **OUTCOME STRUCTURE REVIEW GROUP**

Further to your letter of 6 November 2008 I am pleased to advise that changes to the outcome based management (OBM) structure for the Chemistry Centre have been approved and will apply from the 2008-09 annual reporting period.

The Outcome Structure Review Group (OSRG) met on 7 April 2009 and endorsed the proposed OBM structure subject to the following requirements:

- The Chemistry Centre demonstrate how proposed key effectiveness indicator 4 —
  growth in the aggregated value of the Chemistry Centre components of R&D
  projects is a measure of the quality component of the desired outcome, and how
  aggregated value will be measured;
- As an alternative, an additional key effectiveness indicator to measure the quality of the Chemistry Centre's research and development activities should be submitted for approval prior to 30 June 2009 for inclusion in the Chemistry Centre's 2008-09 annual report; and
- The Chemistry Centre ensures that the proposed client satisfaction survey measures the quality component of the desired outcome.

The OBM structure was subsequently approved by the Under Treasurer subject to the above requirements.

The approved OBM information (refer attached details) should be disclosed in line with the annual reporting requirements outlined in Treasurer's instruction 903, which include the disclosure of the key performance indicators in the Agency Performance section of the annual report.

Please note that, where practicable, comparative information for preceding years will be disclosed in the budget papers (if applicable) and the annual report as the disclosure of trends, over time, contributes to the usefulness of the performance indicators.
