

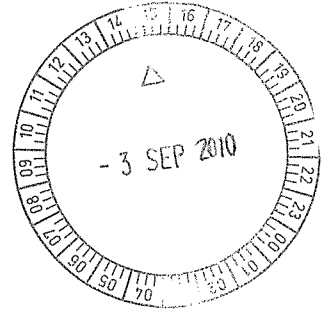

2010-11 QUESTIONS ON NOTICE - BUDGET ESTIMATES HEARINGS

Thank you for your letter of 19 August 2010 concerning the Standing Committee on Estimates and Financial Operations regarding the uncorrected Hansard transcript with questions that Main Roads WA, Department of Transport, and the Public Transport Authority elected to take on notice.

Please find enclosed corrections to the transcript from Department of Transport, Main Roads WA and the Public Transport Authority.

It should be noted that each departmental participant at the Hearing received a copy of the uncorrected transcript requesting corrections be sent back to the Committee. However, in line with previous practice, consolidated corrected transcripts are herewith forwarded to the Committee.

The Department of Transport advises that:

- At page 8, there are two amendments to improve the flow of the document. Firstly, in the first paragraph labelled Mr Fisher, and on the third line of that paragraph, the word *do* should be amended to *use*. Secondly, in the last paragraph, on the fifth line from the bottom, the word *very* should be amended to *through*.
- At page 14, there are also two amendments – one to improve the flow and the other is a typographical correction. Firstly, on Mr Fisher's first comment, the word *show* should be amended to *ensure*. Secondly, the word *markers* should be corrected to *marketers*.

Main Roads advises that:

- Corrections / amendments have been made on pages 5, 6, 7, 8, 12, 16, 21, 28, 29 and in the main these make little difference to the flow of the document but ensure accuracy.
- A correction on page 16, seventh line from the top, where '\$423 million' should read 'on page 423', which has implications as the Hon Philip Gardiner refers to the \$423 million further down the page at two locations.

The Public Transport Authority advises that:

- At page 14, a typographical error has been found which is indicated at the asterisk. (The word *ever* should be *every*.)
- At page 19, also indicated by an asterisk, the station and line referred to as *Armadale* should be shown as *Midland*.

I have attached a letter of invitation to the Estimates and Financial Operations Committee, offering a briefing about Transperth's 2010 Passenger Satisfaction Monitor Survey. Also enclosed are responses to questions taken on notice by each of the three agencies. An electronic copy of the question responses was forwarded to the Committee office on Wednesday, 1 September 2010.
