## COMMITTEE'S FUNCTIONS AND POWERS

On 25 November 2008 the Legislative Council concurred with a resolution of the Legislative Assembly to establish the Joint Standing Committee on the Corruption and Crime Commission.

The Joint Standing Committee's functions and powers are defined in the Legislative Assembly's Standing Orders 289-293 and other Assembly Standing Orders relating to standing and select committees, as far as they can be applied. Certain standing orders of the Legislative Council also apply.

It is the function of the Joint Standing Committee to -

- (a) monitor and report to Parliament on the exercise of the functions of the Corruption and Crime Commission and the Parliamentary Inspector of the Corruption and Crime Commission;
- (b) inquire into, and report to Parliament on the means by which corruption prevention practices may be enhanced within the public sector; and
- (c) carry out any other functions conferred on the Committee under the *Corruption and Crime Commission Act 2003*.

The Committee consists of four members, two from the Legislative Assembly and two from the Legislative Council.



## CHAIRMAN'S FOREWORD

The Joint Standing Committee on the Corruption and Crime Commission spent the majority of the reporting period engaged in its inquiry into *How the Corruption and Crime Commission can best work together with the Western Australian Police Force to combat organised crime*. For this inquiry, which began on 9 September 2009, the Committee convened for a total of 14 closed hearings (12 of which occurred during the reporting period) and seven briefings, hearing evidence from 26 witnesses in a twelve month period. The Committee's consequent Report (*Report 10*) was tabled in Parliament on 9 September 2010.

Through the course of this inquiry, the Committee also continued to discharge its primary function as detailed by Standing Order 289 of the Legislative Assembly, which is to monitor and report to Parliament on the exercise of the functions of the Corruption and Crime Commission and the Parliamentary Inspector of the Corruption and Crime Commission. To this end the Committee tabled four reports in Parliament during the reporting period, owing to issues that were brought to the Committee's attention by either the Corruption and Crime Commission or the Parliamentary Inspector. The Committee also ensured that it remained informed of the Commission's regional outreach program, which saw the Commissioner and a number of senior Commission staff conduct a series of seminars in Karratha and Port Hedland in March 2010. Additionally, the Committee dealt with a number of enquiries pertaining to the work of either the Commission or the Office of the Parliamentary Inspector as raised by members of the public.

At the invitation of the Commissioner, the Committee attended the Corruption and Crime Commission on 23 July 2009 for a tour of the Commission's facilities and a briefing by senior Commission staff. During the tour, the Committee inspected some of the Commission's technical equipment and was impressed with both the capabilities of the Commission and the protocols that govern the use of the Commission's equipment. The Committee returned to the Commission on 26 October 2009 to attend the opening of the public hearings associated with the Commission's investigation into allegations of misconduct in the purchase of goods by public officers.

On 12 November 2009 the Committee tabled its sixth Report, entitled *Parliamentary Inspector's Report into an alleged unauthorised disclosure by the Corruption and Crime Commission*. After receiving a report from the Parliamentary Inspector, Hon Chris Steytler QC, on 3 November 2009, the Committee convened separate closed hearings on 11 November 2009 with the Parliamentary Inspector and the Corruption and Crime Commissioner, Hon Len Roberts-Smith RFD QC. During these hearings the Parliamentary Inspector provided the Committee with some additional information not contained within the original report as to how he had conducted his investigation; at the suggestion of the Committee, the Parliamentary Inspector incorporated this additional information into his report, and the Committee then tabled this report as an appendix to its sixth Report the following day.

On 14 October 2009 the Committee convened a closed hearing with Mr Robert Cock QC, in his capacity as Special Counsel to the Premier, for the purposes of informing its tenth Report. Mr Cock, who served as Western Australia's Director of Public Prosecutions from 2 March 1999 to 30 July 2009, provided significant insight into a range of pertinent issues and the Committee

requested Mr Cock's permission to make the entire transcript of the hearing public. Mr Cock agreed to this request and the Committee tabled the transcript as an appendix to its seventh Report on 26 November 2009.

On 25 February 2010 the Corruption and Crime Commission provided the Committee and, simultaneously, the Attorney General, with a report concerning an investigation into alleged public sector misconduct in relation to the activities of an associate to a judge of the District Court of Western Australia. Having received this report, the Committee convened a closed hearing with the Corruption and Crime Commissioner on 3 March 2010 and discussed both the content of the Report and the reasons cited by the Commissioner as to why the Report had not been tabled directly with Parliament. As a result of this hearing, the Committee requested the Commissioner to provide the Committee with a précis of the original Report, suitable for tabling with Parliament; the Committee then tabled this précis as an appendix to its eighth Report on 18 March 2010 in the Legislative Assembly and 23 March 2010 in the Legislative Council.

On 5 May 2010 the Committee held a public hearing for the purposes of discussing the work and role of the Commission with Ms Gail Archer SC and Mr Christopher Shanahan SC, who serve as Acting Corruption and Crime Commissioners. The Commission's Executive Director, Mr Mike Silverstone, also attended the hearing. The Committee tabled the transcript as an appendix to its ninth Report on 27 May 2010.

During the reporting period, the Committee also concerned itself with the task of providing Parliament with an appraisal of the recommendations contained within the *Review of the Corruption and Crime Commission Act 2003*, completed by Gail Archer SC in February 2008. This work is ongoing, and the Committee intends to table a Report in Parliament concerning the recommendations made by Ms Archer in the near future.

I would like to take this opportunity to thank all the witnesses who appeared before the Committee over the past twelve months, as well as my fellow Committee Members whose support and professionalism are much appreciated.
