Chair's Foreword

This is the first annual report of the Education and Health Standing Committee (EHSC) in the 41st Parliament. This report covers the Committee's activities in the final months of the previous parliament (from July to November 2020) and the current Committee's activities from its formation on 12 May 2021 until 30 June 2021.

The Committee's areas of responsibility cover some of the most important sectors of state government activity. Indeed, in terms of government expenditure the health and education portfolios are the two largest – justifiably so. Keeping our community as healthy as possible while providing educational opportunities that allow individuals to flourish and contribute to the betterment of Western Australia are natural priorities for the government. Using the powers and functions of the Committee we will assist the parliament in its scrutiny and lawmaking functions by holding inquiries into complex issues.

The COVID-19 pandemic has dominated the lives of Western Australians since February 2020. By all measures, Western Australia's success at keeping COVID-19 infection rates at such low levels has been a brilliant achievement. The work of the Western Australian health services is to be acknowledged as a major contributor to our success. During the 40th Parliament and since the pandemic, our predecessors on the EHSC were judicious in their draw on the resources of the health services, but where they felt it necessary sought advice from health officials including the Chief Health Officer. In many ways our successful handling of the pandemic has been a direct result of good government decision-making occurring in unison with strong community support and respect for measures instigated by the McGowan Government.

The Committee of the previous parliament, in the period encompassed by this annual report, undertook an inquiry into the effect COVID-19 had on our education delivery. Report 11, *Lessons From Remote Learning: COVID-19 follow-up to the Inquiry into Digital Innovation in Secondary Education*, recognised COVID-19 as the biggest disruptor to education in recent history. The findings and recommendations from the report provided valuable guidance to our education system in adjusting to the challenges of this new pandemic environment.

Many sectors have had to adapt to the changing circumstances brought about by the pandemic. This has been clear in the initial departmental hearings held to gain an overview of the functions of the Department of Education, the Department of Health and the Mental Health Commission. In his evidence Dr Tarun Weeramanthri, the independent public health consultant and author of the *Climate Health WA Inquiry: Final Report*, noted the speed with which COVID vaccines have been developed, saying similar haste could be applied to climate change responses. Chief Scientist Professor Peter Klinken highlighted the need for a massive transformation of the structure of WA's

tertiary education sector, proposing the merger of all four public universities into a single entity.

I look forward to working productively with my fellow committee members in this 41st Parliament. On their behalf I would also like to acknowledge the work of committee staff, both past and present.

Finally, I would like to pay tribute to the previous chair of the Committee, Ms Janine Freeman, who retired from the parliament at the state election held on 13 March 2021. Under Ms Freeman's leadership the EHSC honoured the tradition of parliamentary committees to undertake independent, well researched inquiries and investigations, further demonstrating that they are a valuable feature of our parliamentary system.

Chapter 1

Introduction

The 2020–2021 reporting period encompasses two parliamentary sessions. The 40th Parliament was dissolved by the Governor on 29 January 2021. This dissolution terminated the parliament and its committees. The Education and Health Standing Committee of the 41st Parliament was established on 12 May 2021.

Reports Tabled

The Committee of the 40th Parliament tabled two reports between July and December 2020, including the annual report.

[Lessons from Remote Learning: COVID-19 follow-up to the Inquiry into Digital Innovation in Secondary Education](#) was tabled on 24 September 2020. This was a short report to assess WA's preparations for remote learning, drawing on the findings of a previous inquiry into opportunities to make better use of digital technology. The Committee found that the ease with which schools transitioned to online learning was dependent on the resources within the school and student access to the internet and a suitable device. Socio-economically disadvantaged students and those in regional areas experienced the most challenges. The report noted that many teachers had to learn digital skills very quickly, highlighting previous concerns about low rates of participation in professional learning. The Department of Education acknowledged that the new modes of teaching applied during remote learning opened the way to explore flexible delivery more broadly.

Other Activities

Briefings

No briefings were held by the Committee during the period 1 July 2020 – 30 June 2021.

Investigative Travel and Conferences

No investigative travel was undertaken, or conferences attended, by the Committee during the reporting period.

Current Activities

The Committee held its first meeting on 26 May 2021. The Committee has commenced agency review hearings within its relevant portfolio areas in order to gather information to inform possible future inquiries.
