To the Legislative Council Standing Committee on Environment and Public Affairs, WA Parliament.

Inquiry into mechanisms for compensation for economic loss to farmers in Western Australia caused by contamination by genetically modified material, including approaches taken in Western Australia and by other jurisdictions and other relevant matters.
