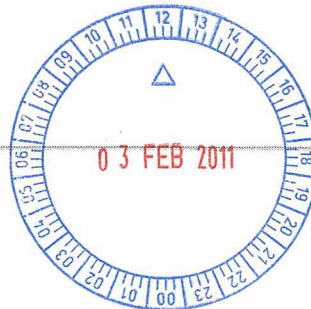

Why is this company getting away with this?? my house is in SSW and on the beelie side and we are getting this every day!!! Every time we have family or friends over EVERY time we need to evacuate in side turn the air con off and then explain what it is and get asked how do they get away with this and what a disgrace it is...

I have no answer and am hoping you can give me an answer ???

The health department is a joke finally changing the rules for Cockburn cement but way to late and after public outcry....why do they get an additional 12 months to get fixed? why does my 8 month old have to breath this is for another 12 months.

What does Mr Barnett doing about this how would he like it if I was outside his house blowing lime dust onto his house and his family breathing it in..

Once again this SSW is 90% of the wind direction my house is covered and I continually have to clean my car with a chemical Barell Clean as it is the only thing to get off.... Im over caring about the damage to my new house which is covered in the dust but VERY concerned about the Health of my 8 month old and my partner who is 2 month pregnant.....

I ask to please advise when this will end for my family and I can get back to my life.
