## PUBLIC STATUTES OF THE SESSION (3).

#### FIFTEENTH PARLIAMENT—SECOND SESSION.

Constitution Acts Amendment (Temporary) Act (25 Geo. V., No. 2)-

An Act to declare that the provisions of Section six of the Constitution Act, 1889, and Sections thirty-two, thirty-four and thirty-eight of the Constitution Acts Amendment Act, 1899, did not apply, and shall not apply, to the office of the chairman of the Lotteries Commission from the appointment to such office to the 31st day of December, 1934; and for other relative purposes. Introduced by the Minister for Police (Hou. H. Millington) 22nd May, 1934. Assent given.

Financial Emergency Act (24 Geo. V., No. 47)-

An Act to make necessary provision for the continuance of the carrying out of a Plan agreed on by the Commonwealth and the States for meeting the grave financial emergency existing in Australia, re-establishing financial stability, and restoring industrial and general prosperity. Introduced by the Premier (Hon. P. Collier) 11th January, 1934. Assent given.

Secession Act (25 Geo. V., No. 1)-

An Act relating to the preparation, completion, and presentation of a dutiful Address to His Majesty, and humble Applications to the House of Lords and to the House of Commons in the Parliament of the United Kingdom in furtherance of the desire of the people of Western Australia to withdraw from the Federal Commonwealth established under the Commonwealth of Australia Constitution Act (Imperial) and for other purposes relative thereto. Introduced by the Premier (Hon. P. Collier) 19th April, 1934. Assent given.
