STATUTE LAW REVISION BILL, 1965.

EXPLANATORY MEMORANDUM.

The Statute Law Revision Act, 1964 was the beginning of a plan to put the Statutes of Western Australia into a form suitable for reprinting.

That Act repealed 384 enactments which were no longer effective and the present Bill is intended to continue the plan by repealing a further 719 enactments most of which were passed after 1900 and all of which are, for the reasons referred to hereunder, thought to be spent, unnecessary or superseded.

The enactments intended to be repealed are set out in the five Schedules to the Bill.

These Schedules are as follows:—

The First Schedule comprises five Parts:

Part I—Supply and appropriation Acts for the period 1901 to 1963.

Part II—Loan Acts under which loans were raised for and appropriated to various public services.

Part III—Miscellaneous Money Acts.

The proposal to repeal the Acts listed in the three preceding Parts is approved by the Treasury.

Part IV—Roads and Streets: This Part contains a number of enactments passed during the period 1832-1963. Their proposed repeal has been examined and approved of by the Department of Lands and Surveys.

Part V—General: This Part contains a number of enactments which are no longer effective. It will be seen that a significant portion of them consists of Acts dealing with emergency conditions which arose during and after the two major wars which have occurred in this century.

The Second Schedule contains a number of Acts relating to railways:

Parts I and II comprise Construction Acts. The reason for their division into separate Parts is explained later in these notes.

Part III consists of a number of Acts authorising the discontinuance of railways; and

Part IV contains a number of miscellaneous railway Acts

All the Acts listed in this Schedule have been examined by the Railways Department and the Commissioner has approved of the proposed repeals.

The Third Schedule contains two enactments each of which it was intended to repeal but which were incorrectly described in the repealing enactments. A Court would probably treat them as repealed, but they are included in this Act to put the matter beyond doubt.

The Fourth Schedule contains four Acts relating to tramways. To ascertain that they are no longer effective it is necessary to have access to a *Government Gazette* of 1913. The purpose of including them in this Bill is to provide a record in the Statutes of the date when they became ineffective.

The Fifth Schedule contains one Act which was passed by the Legislature and reserved for Royal Assent but that assent was never given.

The effect of the repeals contemplated by this Bill is referred to in the Interpretation Act, 1918-1962. In particular, in the present context, it will be noted (S. 12) that the repeal of a repealing enactment does not revive the enactment previously repealed and (S. 16) that a repeal does not affect the operation of the repealed enactment or any right acquired prior to the repeal.

In only one case has any doubt arisen whether the saving provisions of the Interpretation Act are wide enough to ensure that a proposed repeal will not change the law.

Each of the enactments listed in Part I of the Second Schedule authorised the construction of a railway and in most cases authorised deviations to a greater extent than the limit authorised by the Public Works Act, 1902-1961. Subclause (2) of clause 3 of the Bill has been added to ensure that notwithstanding the repeal of the authorising enactment, these authorised limits of deviation are preserved.

The enactments listed in Part II of the Second Schedule also authorised the construction of railways but it is unnecessary to preserve any limit of deviation authorised by them and that is the only reason why they are collected in a separate part.

In the detailed comments which follow it will be noted that the calendar year in which each enactment was assented to is set out and that where the regnal number and the calendar number of the enactment differ both have been shown. So, for instance, the Sale of Liquor Regulation Act, 1915, listed in Part V of the First Schedule was not assented to until 10th January, 1916. Its regnal number is 6 George V No. 30 and its calendar number 63 of 1915.

The confusion which may otherwise occur is illustrated by the Mines Regulation Act Amendment Act, 1915 which is included in the Third Schedule. Its regnal number is 6 George V No. 20 and its calendar number 53 of 1915. In the Act purporting to repeal it, it was described as 5 George V No. 53

It will also be seen that long titles have not been reproduced but short titles have been.

The Bill is not intended to make any alteration in the substance of the law.

Governor authorised to raise sums not exceeding £310,000 for the several works and purposes mentioned in the Schedule.

1943-7 Geo. VI No. 28 (No. 33 of 1943): Loan Act, 1943.

Governor authorised to raise sums not exceeding £350,000 for the several works and purposes mentioned in the Schedule.

1944-No. 32 of 1944: Loan Act, 1944.

Governor authorised to raise sums not exceeding £975,000 for the several works and purposes mentioned in the Schedule.

1945-No. 47 of 1945: Loan Act. 1945.

Governor authorised to raise sums not exceeding £956,000 for the several works and purposes mentioned in the Schedule.

1946-No. 36 of 1946: Loan Act, 1946.

Governor authorised to raise sums not exceeding £5,050,000 for the several works and purposes mentioned in the First Schedule. Certain portions totalling £390,354 18s. of the moneys raised under the Loan Act, 1939, the Loan Act, 1941 and the Loan Act, 1944, were re-appropriated to the works named in the Third Schedule.

1947—No. 83 of 1947: Loan Act, 1947.

Governor authorised to raise sums not exceeding £4,147,000 for the several works and purposes mentioned in the First Schedule. Certain portions totalling £65,441 10s. 2d. of the moneys raised under the Supplementary Loan Act, 1909, the Loan Act, 1911, the Loan Act, 1912, the Loan Act, 1936 and the Loan Act, 1943, were re-appropriated to the works named in the Third Schedule.

1948—No. 85 of 1948: Loan Act, 1948.

Governor authorised to raise sums not exceeding £2,315,000 for the several works and purposes mentioned in the Schedule.

1949—13 Geo. VI No. 137 (No. 51 of 1949): Loan Act. 1949.

Governor authorised to raise sums not exceeding £11,720,000 for the several works and purposes mentioned in the First Schedule. Certain portions totalling £84,918 15s. 10d. of the moneys raised under the Loan Act, 1930 and the Loan Act, 1947, were re-appropriated to the works named in the Third Schedule.

1950-No. 71 of 1950: Loan Act, 1950.

Governor authorised to raise sums not exceeding £14,366,000 for the several works and purposes mentioned in the Schedule.

1951—No. 62 of 1951: Loan Act, 1951.

Governor authorised to raise sums not exceeding £12,535,000 for the several works and purposes mentioned in the First Schedule. A certain portion amounting to £936,562 13s. 1d. of the moneys raised under the Loan Act, 1950, was reappropriated to the works named in the Third Schedule.

1952-No. 67 of 1952: Loan Act, 1952.

Governor authorised to raise sums not exceeding £19,627,000 for the several works and purposes mentioned in the Schedule.

1953-No. 68 of 1953: Loan Act, 1953.

Governor authorised to raise sums not exceeding £17,850,000 for the several works and purposes mentioned in the First Schedule. Certain portions totalling £550,768 3s. 4d. of the moneys raised under the Loan Act, 1924, the Loan Act, 1926, the Loan Act, 1928, the Loan Act, 1933, the Loan Act, 1939, the Loan Act, 1946, the Loan Act, 1949, the Loan Act, 1950, the Loan Act, 1951 and the Loan Act, 1952, were re-appropriated to the works named in the Third Schedule.

1954—No. 37 of 1954: Loan Act, 1954.

Governor authorised to raise sums not exceeding £14,808,000 for the several works and purposes mentioned in the First Schedule. Certain portions totalling £1,909,239 13s. 3d. of the moneys raised under the Loan Act, 1940, the Loan Act, 1941, the Loan Act, 1946, the Loan Act, 1948, the Loan Act, 1951, the Loan Act, 1952 and the Loan Act, 1953, were re-appropriated to the works and purposes named in the Third Schedule.

The Act specifically provided (S. 3) that the sum of £220,000 to be raised for the purpose of funding deficits in the Consolidated Revenue Fund should be so applied by the Treasurer to meet the net accumulated deficit in that fund at 30th June, 1952.

Act

1955-No. 56 of 1955: Loan Act. 1955.

Governor authorised to raise sums not exceeding £11,604,000 for the several works and purposes mentioned in the First Schedule. Certain portions totalling £350,000 of the moneys raised under the Loan Act, 1950, the Loan Act, 1951, the Loan Act, 1953, and the Loan Act, 1954, were re-appropriated to the works and purposes named in the Third Schedule. The Act also provided that the moneys raised under Item 41 of the First Schedule to the Loan Act, 1954, for the purpose of funding deficits in the Consolidated Revenue Fund, should after applying £60,068 9s. 1d to fund the net accumulated deficit at 30th June, 1952, be applied towards funding any deficit in the fund in any subsequent year.

Act.

1906-No. 9 of 1906: State Savings Bank Act, 1906.

The short title of this Act was originally the Government Savings Bank Act, 1906, until changed by the Government Savings Bank Act Amendment Act. No. 13 of 1926 (infra).

The Act consolidated and amended the law relating to the then existing Post Office Savings Bank established under The Post Office Savings Bank Consolidation Act, 1893 (57 Vict. No. 3), by repealing that Act and its amendments and constituting the existing bank and all branches and agencies thereof as the Government Savings Bank. By an agreement dated 15th August, 1931, the whole of the Bank's business and assets (with the exception of a property in Barrack Street), were transferred to the Commonwealth Savings Bank of Australia, and such Agreement was ratified by the State Savings Bank Transfer Act. No. 26 of 1931 (infra).

1907-No. 16 of 1907: Land Tax and Income Tax Act, 1907.

This Act prescribed the rates of land tax and income tax payable for the year ended 30th June, 1908.

1908-No. 5 of 1908: Land Tax and Income Tax Act, 1908.

This Act prescribed the rates of land tax and income tax payable for the year ended 30th June, 1909.

1909—9 Edw. VII No. 36 (No. 40 of 1909): Land Tax and Income Tax Act, 1909.

This Act prescribed the rates of land tax and income tax payable for the year ended 30th June, 1910.

1910-No. 5 of 1910: General Loan and Inscribed Stock Act, 1910.

This Act consolidated and amended the law relating to loans authorised to be raised by the Government and the creation and issue of inscribed stock and debentures by repealing the General Loan and Inscribed Stock Act, 1884 and its amendments and the Local Inscribed Stock Act, 1897 and its amendments. Provisions of general application included the raising of loans by the issue of Inscribed Stock or debentures or both, the appropriation out of the revenues and assets of the State of moneys to form a sinking fund for the redemption of the issued securities, the application of such fund and the manner of its investment, the rate of interest on issued securities and the appointment of authorised agents and their powers, whilst particular provisions were concerned with debentures, loans domiciled with Crown Agents for the Colonies and inscribed stock issued in Western Australia.

1910-No. 11 of 1910: Land Tax and Income Tax Act, 1910.

This Act prescribed the rates of land tax and income tax payable for the year ended 30th June, 1911.

1911—2 George V No. 5 (No. 49 of 1911): Land Tax and Income Tax Act. 1911.

This Act prescribed the rates of land tax and income tax payable for the year ended 30th June, 1912.

1912—3 Geo. V No. 52 (No. 71 of 1912): Land Tax and Income Tax Act, 1912.

This Act prescribed the rates of land tax and income tax payable for the year ended 30th June, 1913.

1913-No. 25 of 1913: Land Tax and Income Tax Act, 1913.

This Act prescribed the rates of land tax and income tax payable for the year ended 30th June, 1914.

1914-No. 2 of 1914: Land Tax and Income Tax Act, 1914.

This Act prescribed the rates of land tax and income tax payable for the year ended 30th June, 1915.

1915—6 Geo. V No. 3 (No. 36 of 1915): Land Tax and Income Tax Act, 1915.

This Act prescribed the rates of land tax and income tax payable for the year ended 30th June, 1916.

1915—6 Geo. V No. 16 (No. 49 of 1915): General Loan and Inscribed Stock Act Amendment Act, 1915.

This Act amended section 18 of the General Loan and Inscribed Stock Act, No. 5 of 1910, so as to increase the maximum rate of interest payable on inscribed stock and debentures to 5 per cent. per annum.

Year, Act.

1917—7 Geo. V No. 25 (No. 5 of 1917): Land Tax and Income Tax Act, 1917.

This Act prescribed the rates of land tax and income tax payable for the year ended 30th June, 1917.

1917—7 Geo. V No. 37 (No. 17 of 1917): Treasury Bonds Deficiency Act, 1916.

This Act authorised the Governor during the three years following 28th March, 1917, to raise a loan of £1,500,000 by the issue of Treasury Bonds or Inscribed Stock to provide for the deficiency of the Consolidated Revenue Fund up to 30th June, 1916. Such deficiency was to be debited to a special Deficiency Account to be opened at the Treasury, and the proceeds of the bonds or stock so issued were to be applied in liquidating the deficiency. Other provisions concerned the application of the General Loan and Inscribed Stock Act. 1910, to the bonds and stock so issued, the date of issue, currency, redemption, and renewal of the same, sinking fund contributions, the charging of principal and interest (at a maximum rate of 6 per cent. per annum), on the Consolidated Revenue Fund, the power of trustees and others to invest and the power of the Treasurer to pay off or redeem. Section 4 empowered the Treasurer during the financial year ending 30th June, 1917, and in any subsequent financial year, to apply any moneys standing to the credit of the Public Account to meet expenditure authorised by the Supply and Appropriation Acts in force for the time being and also provided that if at the end of any financial year it should appear that expenditure authorised from the Consolidated Revenue Fund had exceeded the revenue for that year, the matter should be reported to Parliament. either immediately, if in session, or if not, then as soon as practicable after the next meeting thereof.

1917—8 Geo. V No. 12 (No. 31 of 1917): Land Tax and Income Tax Act, 1917 (No. 2).

This Act prescribed the rates of land tax and income tax payable for the year ended 30th June, 1918.

1918—8 Geo. V No. 21 (No. 7 of 1918): Treasury Bonds Deficiency Act, 1918.

This Act authorised the Governor, during the three years following the passing of the same, to raise a loan of £650,000 by the issue of Treasury Bonds or Inscribed Stock to provide for the deficiency of the Consolidated Revenue Fund up to 30th June, 1917. Such deficiency was to be debited to the Deficiency Account, opened pursuant to the Treasury Bonds Deficiency Act, 1916 (supra), and the proceeds of the bonds or stock issued under this Act were to be applied to the liquidation of such deficiency. Sections 5-9 inclusive of the 1916 Act, were incorporated with this Act, which further

provided that the Governor could suspend payment of contributions to the sinking fund for the redemption of bonds or stock issued under the authority of either Act.

1918—9 Geo. V No. 10 (No. 20 of 1918); General Loan and Inscribed Stock Act Amendment Act, 1918.

This Act amended section 18 of the General Loan and Inscribed Stock Act, No. 5 of 1910, so as to increase the maximum rate of interest payable on certain inscribed stock and debentures to $6\frac{1}{2}$ per cent. per annum. The Act expired on 30th September, 1919.

1918—9 George V No. 13 (No. 23 of 1918): Land Tax Adjustment Act, 1918.

This Act provided for an adjustment of the land tax payable for the year ended 30th June, 1918, as prescribed by No. 31 of 1917 (supra).

1918—9 Geo. V No. 15 (No. 25 of 1918): Land Tax and Income Tax Act, 1918.

This Act prescribed the rates of land tax and income tax payable for the year ended 30th June, 1919.

1918-9 Geo. V No. 29 (No. 39 of 1918): Income Tax Act, 1918.

This Act prescribed a method of calculation of the income tax payable for the year ended 30th June, 1919, as prescribed by No. 25 of 1918 (supra).

1919—9 Geo. V No. 35 (No. 5 of 1919): Treasury Bonds Deficiency Act, 1918 (No. 2).

This Act authorised the Governor during the three years following 3rd January, 1919, to raise a loan of £750,000 by the issue of Treasury Bonds or Inscribed Stock to provide for the deficiency of the Consolidated Revenue Fund up to 30th June, 1918. Such deficiency was to be debited to the Deficiency Account opened pursuant to the Treasury Bonds Deficiency Act, 1916 (supra) and the proceeds of the bonds or stock issued under this Act were to be applied to the liquidation of such deficiency. Paragraph (6) of the proviso to section 6 of the 1916 Act (providing for contributions to a sinking fund for the redemption of bonds or stock) was repealed whilst sections 5, 7-9 and the balance of section 6 of the 1916 Act were incorporated with this Act.

1919—10 Geo. V No. 6 (No. 18 of 1919): General Loan and Inscribed Stock Act Amendment Act, 1919.

This Act reduced, for the period of 1st October, 1919 to 30th September, 1920, the maximum rate of interest payable under section 18 of the General Loan and Inscribed Stock Act, No. 5 of 1910 to 6 per cent. per annum.

1919—10 Geo. V No. 14 (No. 26 of 1919): Land Tax and Income Tax Act, 1919.

This Act prescribed the rates of land tax and income tax payable for the year ended 30th June, 1920.

1919—10 Geo. V No. 23 (No. 35 of 1919): Treasury Bonds Deficiency Act, 1919.

This Act authorised the Governor, during the three years following 17th December, 1919 to raise a loan of £680,000 by the issue of Treasury Bonds or Inscribed Stock to provide for the deficiency of the Consolidated Revenue Fund up to 30th June, 1919. Such deficiency was to be debited to the Deficiency Account opened pursuant to the Treasury Bonds Deficiency Act, 1916 (supra) and the proceeds of the bonds or stock issued under this Act were to be applied to the liquidation of such deficiency. The Act further provided for the consolidation of existing Acts, i.e., Nos. 17 of 1917, 7 of 1918, and 5 of 1919 (supra) providing for the funding of deficiencies of previous years with this Act, and the authority to raise money under the several Acts was to be applied to cover the deficiencies in the Consolidated Revenue Fund for the several years. Sections 5-9 of the 1916 Act were also incorporated with this Act.

1920-No. 5 of 1920: Local Authorities Sinking Funds Act, 1920.

This Act authorised local authorities to invest their contributions to sinking funds formed for the purpose of liquidating loans in Treasury Bonds issued under the War Gratuity Act, 1920 of the Commonwealth. All such bonds matured no later than 31st May, 1924. (See Commonwealth Year Book, No. 17, 1924, p. 598).

1920-No. 13 of 1920: Treasury Bonds Deficiency Act, 1920.

This Act authorised the Governor during the three years following 29th November, 1920 to raise a loan of £690,000 by the issue of Treasury Bonds or Inscribed Stock to provide for the deficiency of the Consolidated Revenue Fund up to 30th June, 1920. Such deficiency was to be debited to the Deficiency Account opened pursuant to the Treasury Bonds Deficiency Act, 1916 (supra) and the proceeds of the bonds or stock issued under this Act were to be applied to the liquidation of such deficiency. This Act was consolidated with the four previous Acts so as to enable the authority to raise money thereby conferred to be applied to the deficiencies for the several years. Sections 5-9 of the 1916 Act were also incorporated with this Act.

1920—No. 40 of 1920: General Loan and Inscribed Stock Act Amendment Act, 1920.

This Act increased the rate of interest payable under section 18 of the General Loan and Inscribed Stock Act, No. 5 of 1910 to $6\frac{1}{2}$ per cent. per annum. The Act expired on 31st December, 1921.

1920-No. 48 of 1920: Land Tax and Income Tax Act, 1920.

This Act prescribed the rates of land tax and income tax payable for the year ended 30th June, 1921.

1921-No. 1 of 1921: Treasury Bills (Signatures) Act, 1921.

This Act authorised the Agent General in London and the Accountant at the London Agency in lieu of the Colonial Treasurer and the Under Treasurer to sign Treasury Bills made out and issued in London under the authority of 57 Vict. No. 2 of 1893 and its amendments for the purpose of raising a sum not exceeding £2,000,000. It was apparently intended that the Act should have effect in respect of only one particular loan raised in London (see *Hansard* Vol. 64 (New Series) pp. 14-15) and in any event its provisions were superseded by the Treasury Bills Act, 1929 (infra).

1921-No. 15 of 1921: Land Tax and Income Tax Act, 1921.

This Act prescribed the rates of land tax and income tax payable for the year ended 30th June, 1922.

1921—No. 32 of 1921: General Loan and Inscribed Stock Act Amendment Act, 1921.

By this Act the maximum rate of interest payable under section 18 of the General Loan and Inscribed Stock Act, No. 5 of 1910 continued to be $6\frac{1}{2}$ per cent. per annum until 31st December, 1922.

1922—13 Geo. V No. 23 (No. 41 of 1922): Land Tax and Income Tax Act, 1922.

This Act prescribed the rates of land tax and income tax payable for the year ended 30th June, 1923.

1923—13 Geo. V No. 31 (No. 8 of 1923): General Loan and Inscribed Stock Act Amendment Act, 1922.

By this Act the maximum rate of interest payable under section 18 of the General Loan and Inscribed Stock Act, No. 5 of 1910, was fixed at 6 per cent. per annum until 31st December, 1923.

1923—13 Geo. V No. 40 (No. 17 of 1923): Land Tax and Income Tax Act Amendment Act, 1923.

This Act amended No. 41 of 1922 (*supra*) by the addition of certain words to and the substitution of a new subsection (1) in section 6.

1923—14 Geo. V No. 24 (No. 45 of 1923): General Loan and Inscribed Stock Act Continuance Act, 1923.

By this Act the General Loan and Inscribed Stock Act Amendment Act, 1922 which fixed the maximum rate of interest payable under section 18 of the General Loan and Inscribed Stock Act, No. 5 of 1910 at 6 per cent. per annum, was continued until 31st December, 1924.

1923—14 Geo. V No. 36 (No. 57 of 1923): Land Tax and Income Tax Act, 1923.

This Act prescribed the rates of land tax and income tax payable for the year ended 30th June, 1924.

1924—No. 11 of 1924: General Loan and Inscribed Stock Act Continuance Act, 1924.

By this Act the General Loan and Inscribed Stock Act Amendment Act, 1922, which fixed the maximum rate of interest payable under section 18 of the General Loan and Inscribed Stock Act, No. 5 of 1910 at 6 per cent. per annum, was continued until 31st December, 1925.

1924—No. 18 of 1924: Treasury Bills Act Amendment Act, 1924.

This Act increased, until 31st December, 1925, the maximum rate of interest payable on Treasury Bills issued under 57 Vict. No. 2 of 1893, from £5 per centum per annum, to £6 per centum per annum.

1924—No. 32 of 1924: Treasury Bonds Deficiency Act, 1924.

This Act authorised the Governor to raise a loan of £2,050,000 by the issue of Treasury Bonds or Inscribed Stock to provide for the deficiency in the Consolidated Revenue Fund up to 30th June, 1924. Such deficiency (comprising the debts for the several years ending 30th June, 1921, 1922, 1923, and 1924), was to be debited to the Deficiency Account, opened pursuant to the Treasury Bonds Deficiency Act, 1916 (supra), and the proceeds of the bonds or stock issued under this Act, were to be applied to the liquidation of such deficiency. This Act was consolidated with the five previous Acts, so as to enable the authority to raise money thereby conferred, to be applied to the deficiencies for the several years. The Act also validated the issue of bonds or stock under Act No. 13 of 1920, notwithstanding the lapse of three years and incorporated sections 5-9 of the 1916 Act with this Act.

1924—No. 38 of 1924: Land Tax and Income Tax Act, 1924.

This Act prescribed the rates of land tax and income tax payable for the years ended 30th June, 1925, and 30th June, 1926.

1925-No. 6 of 1925.

This Act amended No. 38 of 1924 (supra), by the addition of certain words to section seven, so that section 56 of the Land and Income Tax Assessment Act, No. 15 of 1907, allowing taxes in excess of 20s., to be paid in two half-yearly instalments, should not apply to the year ended 30th June, 1926.

1925—No. 31 of 1925: General Loan and Inscribed Stock Act Amendment Act, 1925.

By this Act the maximum rate of interest payable under section 18 of the General Loan and Inscribed Stock Act, No. 5 of 1910 was, as from 1st January, 1926, fixed at 5½ per cent. per annum, and section 10 of the principal Act was also amended so as to provide that sinking fund contributions for the redemption of loans issued by the Commonwealth Government on behalf of the State, might accrue from the date of issue of such loans instead of four years after issue as originally provided and that such sinking fund contributions should be paid to the Commonwealth and be subject to the provisions of the National Debt Sinking Fund Act, 1923-1924.

1926-No. 7 of 1926: Federal Aid Roads Agreement Act, 1926.

This was an Act to ratify the agreement dated 1st July, 1926, made between the Commonwealth and the State relating to the distribution by the Commonwealth to the State over a period of ten years of the sum of £3,840,000 being the State's share of the total amount of £2,000,000 per annum to be made available for the purpose of the construction and reconstruction of certain roads which were designated "Federal Aid Roads".

The Agreement was varied in certain respects in 1931 and its term extended for a period of six months from 1st July, 1936 (see Federal Aid Roads Agreement Act, No. 16 of 1931, *infra*), and in 1936 the original Agreement as so varied was extended for a further six months from 1st January, 1937 (see Federal Aid Roads Agreement Act, No. 25 of 1936. *infra*).

In 1937, a new agreement to operate for a period of ten years, from 1st July, 1937, was entered into (see Federal Aid Roads (New Agreement Authorisation) Act, No. 33 of 1936, as amended by Federal Aid Roads (New Agreement Authorisation) Act Amendment Act, No. 2 of 1937, intra).

1926—No. 13 of 1926: Government Savings Bank Act Amendment Act, 1926.

This Act made certain amendments to No. 9 of 1906 (above) including changing the name of the Bank to "The State Savings Bank of Western Australia."

1926-No. 20 of 1926: Land Tax and Income Tax Act, 1926.

This Act prescribed the rates of land tax and income tax payable for the year ended 30th June, 1927.

1927—No. 14 of 1927: Loan and Inscribed Stock (Sinking Fund) Act, 1927.

By this Act the Governor was authorised with the consent of the trustees of the sinking fund for the redemption of loans domiciled with the Crown Agents for the Colonies,

(i.e. those loans raised prior to responsible government), to suspend the contribution to the sinking fund if the trustees were satisfied that the value of the fund for the time being was sufficient to enable the loan to be redeemed on the due date (see *Hansard* Vol. 76 (New Series) p. 1104).

1927-No. 18 of 1927: Land Tax and Income Tax Act, 1927.

This Act prescribed the rates of land tax and income tax payable for the year ended 30th June, 1928.

1928-No. 16 of 1928: Land Tax and Income Tax Act, 1928.

This Act prescribed the rates of land tax and income tax payable for the year ended 30th June, 1929.

1929—20 Geo. V No. 2 (No. 4 of 1929): Workers' Homes Act, 1929.

This Act authorised the State, by the Treasurer, to guarantee the payment by the Workers' Homes Board (later replaced by the State Housing Commission under the State Housing Act, No. 51 of 1946) to the Commonwealth Savings Bank of Australia of all principal and interest due and to become due from the Board to the Bank in respect of advances both past and future made under the Commonwealth Housing Act, 1927-1928, which legislation was later repealed by the Commonwealth Bank Act, 1945.

1929-20 Geo. V No. 13 (No. 15 of 1929): Treasury Bills Act, 1929.

This Act authorised the Agent General in London and the Accountant at the London Agency in lieu of the Treasurer and the Under Treasurer, to sign Treasury Bills made out and issued in London under the authority of 57 Vict. No. 2 of 1893 and the Treasury Bills Act Amendment Act, 1916. The Act was expressed to be subject to the Financial Agreement Act, 1928 and the agreement thereby approved, and specifically provided that the interest payable on such bills should be at a rate determined by the Australian Loan Council.

1929—20 Geo. V No. 35 (No. 37 of 1929): Land Tax and Income Tax Act, 1929.

This Act prescribed the rates of land tax and income tax payable for the year ended 30th June, 1930.

1930—No. 10 of 1930: Land Tax and Income Tax Act, 1930.

This Act prescribed the rates of land tax and income tax payable for the year ended 30th June, 1931.

1931—No. 16 of 1931: Federal Aid Roads Agreement Act, 1931.

This Act ratified the Agreement dated 21st July, 1931 made between the Commonwealth and the State and which made certain alterations to the Federal Aid Roads Agreement Act of 1926 (see No. 7 of 1926 supra) and continued the same until 31st December, 1936.

1931-No. 20 of 1931: Financial Emergency Act, 1931.

This Act was the first enactment passed for the purpose of carrying out the "Premiers' Plan" adopted on 10th June. 1931 at the Conference of Premiers in Melbourne convened to discuss the financial crisis then existing in The Act dealt with reductions in salaries. Australia. wages, superannuation and retiring allowances. government grants; the variation of contracts of service of outside employees, i.e. those in non-Governmental service: and the reduction of mortgagors' interest. Section 26 provided that the Act should continue in force until 31st December, 1932. By the Financial Emergency Act Continuance Act, No. 27 of 1932, the duration of the principal Act was extended to 31st December, 1933, but no longer. On 1st January, 1934 the Financial Emergency Act, No. 1 of 1934 (infra) came into operation.

1931-No. 26 of 1931: State Savings Bank Transfer Act, 1931.

This Act ratified the Agreement whereby the business and assets of the State Savings Bank (constituted under No. 9 of 1906) were transferred to the Commonwealth Savings Bank of Australia. The employment, long service leave, superannuation and other rights of existing employees were protected and the Agreement was to run for a period of 25 years from 15th August, 1931, the State of Western Australia having the option of continuing the same for a further period not exceeding 20 years.

1931-No. 35 of 1931: Land Tax and Income Tax Act, 1931.

This Act prescribed the rates of land tax and income tax payable for the year ended 30th June, 1932.

1932-No. 12 of 1932: Land Tax and Income Tax Act, 1932.

This Act prescribed the rates of land tax and income tax payable for the year ended 30th June, 1933.

1932—No. 15 of 1932: Financial Emergency Tax Act, 1932.

This Act prescribed the rate of Financial Emergency Tax to be paid upon income, salary and wages pursuant to the Financial Emergency Tax Assessment Act, No. 20 of 1932 (infra) for the financial year ended 30th June, 1933.

1932-No. 20 of 1932: Financial Emergency Tax Assessment Act, 1932.

This Act imposed on all persons including incorporated bodies, in receipt of income, salary or wages the liability to pay the financial emergency tax at the rates prescribed by the annual Financial Emergency Tax Acts passed between 1932 and 1939, and provided the method of assessment and collection of such tax. The Act was amended several times between 1933 and 1940 (infra). Financial emergency tax was last imposed for the financial year ended 30th June, 1940 from which date this Act ceased to operate.

- 1932—No. 27 of 1932: Financial Emergency Act Continuance Act, 1932.

 This Act continued the operation of the Financial Emergency Act, No 20 of 1931 (supra), until 31st December, 1933.
- 1933-No. 14 of 1933: Financial Emergency Tax Act, 1933.
 - This Act prescribed the rates of financial emergency tax to be paid upon income salary and wages pursuant to the Financial Emergency Tax Assessment Act, No. 20 of 1932, as amended (*supra*), for the period 1st July, 1933, until 31st December, 1934.
- 1933—No. 15 of 1933: Financial Emergency Tax Assessment Act Amendment Act, 1933.
 - This Act amended the principal Act, No. 20 of 1932 (supra), by extending the exemptions of salary and wage earners from liability for payment of the financial emergency tax, and consequently altering the provisions dealing with the deduction of tax from salary and wages and providing that tax not paid or deducted was to be a charge on future salary or wages. The principal Act ceased to operate on 30th June, 1940.
- 1933—No. 16 of 1933: Wiluna Water Board Loan Guarantee Act, 1933.

 This Act authorised the Treasurer to guarantee on behalf of the Wiluna Water Board repayment of the principal sum and interest of a loan of £8,000 proposed to be raised by the Board for the purpose of providing and maintaining an efficient and sufficient water supply in the Wiluna Water Area. (See also No. 18 of 1935 infra.)
- 1933—No. 29 of 1933: Land Tax and Income Tax Act, 1933.

 This Act prescribed the rates of land tax and income tax payable for the year ended 30th June, 1934.
- 1934—24 George V No. 47 (No. 1 of 1934): Financial Emergency Act, 1934.
 - The Financial Emergency Act, No. 20 of 1931 (supra) expired on 31st December, 1933. This Act continued with some amendments as from 1st January, 1934, the plan for dealing with the continuing financial emergency until 31st December, 1934. The Act was partially repealed (section 18), amended, and extended until 31st December, 1935, by the Financial Emergency Act Amendment Act, No. By the Financial Emergency Act 26 of 1934 (infra). Amendment Act, No. 19 of 1935 (infra), Parts II to IV (inclusive), dealing with salaries, superannuation and retiring allowances and government grants and the Schedule prescribing the rates of reduction of salaries were repealed as from 1st January, 1936, whilst the remainder of the principal Act (being chiefly Part V dealing with the reduction of mortgagors' interest) was continued until 31st December, 1936, together with an amendment providing for computation of superannuation

and retiring allowances at salary rates existing prior to the passing of the Financial Emergency Act, No. 20 of 1931. The principal Act continued to be renewed each year by a series of annual Acts passed between 1936 and 1946, the last occasion being the passing of the Financial Emergency Act Amendment Act, No. 59 of 1946, which continued the operation of the principal Act until 30th November, 1947, from which date it ceased to operate.

1934—25 Geo. V. No. 17 (No. 18 of 1934): Land Tax and Income Tax Act, 1934.

This Act prescribed the rates of land tax and income tax payable for the year ended 30th June, 1935.

1934—25 Geo. V No. 25 (No. 26 of 1934): Financial Emergency Act Amendment Act, 1934.

This Act amended sections 6 and 7 and repealed section 18 of the Financial Emergency Act, No. 1 of 1934 (supra), and continued the operation of the principal Act as so amended until 31st December, 1935.

1934—25 Geo, V No. 30 (No. 31 of 1934): Financial Emergency Tax Act, 1934.

This Act prescribed the rates of financial emergency tax to be paid upon incomes, salary and wages pursuant to the Financial Emergency Tax Assessment Act, No. 20 of 1932, as amended (supra), for the period 1st January, to 31st December, 1935.

1934—25 Geo. V No. 31 (No. 32 of 1934): Financial Emergency Tax Assessment Act Amendment Act. 1934.

This Act further amended the principal Act, No. 20 of 1932 (supra), by again extending the exemptions of salary and wage earners from liability for payment of tax, and for assessment and payment of tax on aggregates of income with salary and wages. The principal Act ceased to operate on 30th June, 1940.

1935-No. 7 of 1935: Land Tax and Income Tax Act, 1935.

This Act prescribed the rates of land tax and income tax payable for the year ended 30th June, 1936.

1935—No. 18 of 1935: Wiluna Water Board Further Loan Guarantee Act, 1935.

This Act authorised the Treasurer to guarantee on behalf of the Wiluna Water Board repayment of the principal sum and interest of a further loan of £7,500 proposed to be raised by the Board for the purpose of extending the water supply in the Wiluna Water Area (see also No. 16 of 1933 above).

1935—No. 19 of 1935: Financial Emergency Act Amendment Act, 1935.

This Act repealed Parts II to IV (inclusive) and the Schedule of the principal Act, No. 1 of 1934 (supra), provided for computation of superannuation and retiring allowances

at salary rates existing prior to the passing of the Financial Emergency Act, No. 20 of 1931, and continued the operation of the principal Act until 31st December, 1936.

1935-No. 23 of 1935: Financial Emergency Tax Act, 1935.

This Act prescribed the rates of financial emergency tax to be paid upon income, salary and wages pursuant to the Financial Emergency Tax Assessment Act, No. 20 of 1932, as amended (supra), for the period 1st January, to 31st December, 1936.

1936—No. 9 of 1936: Land Tax and Income Tax Act, 1936.

This Act prescribed the rates of land tax and income tax payable for the year ended 30th June, 1937.

1936—No. 18 of 1936: Financial Emergency Act Amendment Act, 1936.

This Act continued the operation of the principal Act No. 1 of 1934, as amended (supra), until 31st December, 1937.

1936—No. 25 of 1936: Federal Aid Roads Agreement Act, 1936.

This Act ratified the Agreement dated 4th August, 1936, made between the Commonwealth and the State whereby the Federal Aid Roads Agreement Act of 1926 (see No. 7 of 1926 supra), as amended by the Federal Aid Roads Agreement Act of 1931 (see No. 16 of 1931 supra), was continued until 30th June, 1937.

1936—No. 30 of 1936: Financial Emergency Tax Act (No. 3), 1936.

This Act prescribed the rates of financial emergency tax to be paid upon income, salary and wages, pursuant to the Financial Emergency Tax Assessment Act, No. 20 of 1932 as amended (supra), for the year ended 30th June, 1937, i.e., for the six months ended 31st December, 1936—at the rates prescribed in No. 23 of 1935 (supra); and for the six months ended 30th June, 1937, at the rates prescribed in the Schedule of this Act.

1936—No. 33 of 1936: Federal Aid Roads (New Agreement Authorisation) Act, 1936.

This Act authorised the Premier to execute for and on behalf of the State, a new Agreement to be made with the Commonwealth relating to Federal Aid Roads for a period of ten years from 1st July, 1937. The provisions in the Agreement dealing with the State's obligations in regard to expenditure of the moneys to be provided by the Commonwealth were amended retrospectively by the Federal Aid Roads (New Agreement Authorisation) Act Amendment Act, No. 2 of 1937 (infra).

1936-No. 37 of 1936: Financial Emergency Tax Assessment Act Amendment Act (No. 2), 1936.

> This Act further amended the principal Act, No. 20 of 1932 (supra), by again extending the exemption of salary and wage earners from liability for payment of tax, and providing consequently for a refund of tax overpaid. The principal Act ceased to operate on 30th June, 1940.

1937-No. 2 of 1937: Federal Aid Roads (New Agreement Authorisation) Act Amendment Act, 1937.

> This Act amended retrospectively to the date of commencement of Act No. 33 of 1936 (supra), the form of Agreement contained in the Schedule to that Act by deleting certain clauses and substituting new clauses in their place.

1937—No. 17 of 1937: Financial Emergency Act Amendment Act, 1937. This Act continued the operation of the principal Act, No. 1 of 1934, as amended (supra) until 31st December, 1938.

1937-No. 21 of 1937: Financial Emergency Tax Assessment Act Amendment Act, 1937.

> This Act further amended the principal Act, No. 20 of 1932 (supra), by making employers and others paying salary or wages jointly and severally liable for failure to collect the amount of tax due and by making three years the period of limitation for prosecution for any offence against the Act or regulations. The principal Act ceased to operate on 30th June, 1940.

1937-No. 22 of 1937: Land Tax and Income Tax Act, 1937.

This Act prescribed rates of taxation as follows:—

- (a) Land tax payable for the year ended 30th June, 1938.
- (b) Income tax payable by all persons other than companies for the year ended 30th June, 1938.
- (c) Income tax payable by companies and on racing stakes for the year ended 30th June, 1938, and for each subsequent year of assessment until otherwise determined by Parliament. This provision superseded by sections 4 and 7 of the Income Tax Act, No. 14 of 1940 (infra), which prescribed new rates of taxation as from 1st July, 1940.
- 1937—No. 30 of 1937: Financial Emergency Tax Assessment Act Amendment Act, 1937.

This Act further amended the principal Act, No. 20 of 1932 (supra) by again extending the exemptions of salary and wage earners from liability for payment of tax. principal Act ceased to operate on 30th June, 1940.

1937-No. 33 of 1937: Financial Emergency Tax Act, 1937.

This Act prescribed the rates of financial emergency tax to be paid upon income, salary and wages, pursuant to the Financial Emergency Tax Assessment Act, No. 20 of 1932 as amended (*supra*), for the year ended 30th June, 1938.

It was amended by the substitution of certain words by Part II of the Special Tax Acts Revision Act, No. 40 of 1937.

1938—No. 12 of 1938: Land Tax and Income Tax Act, 1938.

This Act prescribed the rates of:-

- (a) land tax; and
- (b) income tax payable by all persons other than companies,

payable for the year ended 30th June, 1939.

1938-No. 18 of 1938: Financial Emergency Tax Act, 1938.

This Act prescribed the rates of financial emergency tax to be paid upon income, salary and wages, pursuant to the Financial Emergency Tax Assessment Act, 1932-1937 (Consolidated), for the year ended 30th June, 1939.

1938—No. 19 of 1938: Financial Emergency Tax Assessment Act Amendment Act, 1938.

Section 4 of the Financial Emergency Tax Assessment Act, 1932-1937 (Consolidated), provided *inter alia* that persons regularly maintaining or contributing to the maintenance of one or more members of their family resident and domiciled in Western Australia, should be exempt from liability for taxation in respect of salary or wages received after 31st December, 1937, to the extent of £3 17s. per week, provided they had no other source of income.

This Act increased the maximum amount of weekly income to £4 2s. from 31st December, 1938.

1938—No. 25 of 1938: Financial Emergency Act Amendment Act, 1938.

This Act continued the operation of the principal Act, No. 1

of 1934, as amended (*supra*), until 31st December, 1939.

1938—No. 26 of 1938: Financial Emergency Tax Assessment Act Amendment Act, 1938.

This Act amended the procedure whereby arrangements were made for payment of the State financial emergency tax by employees of the Commonwealth by deductions from their salaries or wages. Previously such arrangements had been made between the Governor of the State and the Governor General of the Commonwealth. Consequent upon an amendment to the Income Tax Collection Act, 1932-1938 of the Commonwealth, the purpose of this Act was to provide that the State might enter into an agreement with the Commonwealth in lieu of the previous provision.

1939—No. 10 of 1939: Financial Emergency Act Amendment Act, 1939.

This Act continued the operation of the principal Act, No. 1

of 1934, as amended (*supra*), until 31st December, 1940.

1939—No. 49 of 1939: Financial Emergency Tax Assessment Act Amendment Act, 1939.

This Act amended section 4 (a) of the Financial Emergency Tax Assessment Act, 1932-1938 (supra), by further extending the exemptions of those income, salary, and wage earners who regularly maintained or contributed to the maintenance of members of their families resident and domiciled in Western Australia.

1939-No. 51 of 1939: Land Tax and Income Tax Act, 1939.

This Act prescribed the rates of:—

- (a) land tax; and
- (b) income tax payable by all persons other than companies,

payable for the year ended 30th June, 1940.

1939—No. 52 of 1939: Financial Emergency Tax Act, 1939.

This Act prescribed the rates of financial emergency tax to be paid upon income, salary and wages, pursuant to the Financial Emergency Tax Assessment Act, 1932-1938, for the year ended 30th June, 1940.

1940—No. 2 of 1940: Financial Emergency Tax Assessment Act Amendment Act, 1940.

This Act amended section 9 (7) of the Financial Emergency
Tax Assessment Act, 1932-1938, so as to permit refunds
to those persons who during the financial year ended
30th June, 1940, paid excess taxation on their wages or
salary. Financial emergency tax had ceased on 30th
June, 1940, and this Act provided that for the purpose of
calculating refunds the same rates should apply as were
levied during the financial year ending on that date.

1940—No. 13 of 1940: Land Tax Act, 1940.

This Act prescribed the rate of land tax payable for the year ended 30th June, 1941 and for each subsequent year of assessment until otherwise determined by Parliament. The Act was superseded by the Land Tax Act, No. 32 of 1948, which prescribed new rates of taxation as from 1st July, 1948.

1940-No. 14 of 1940: Income Tax Act, 1940.

This Act prescribed the rates of income tax payable for the year commencing 1st July, 1940.

1940—No. 27 of 1940: Financial Emergency Act Amendment Act, 1940.

This Act continued the operation of the principal Act, No. 1 of 1934, as amended (supra), until 31st December, 1941.

1941-No. 13 of 1941: Income Tax Act, 1941.

This Act, as amended by section 3 of the Income and Entertainments Tax (War Time Suspension) Act, No. 41 of 1942, prescribed the rates of income tax payable for the year commencing 1st July, 1941.

- 1941—No. 24 of 1941: Financial Emergency Act Amendment Act, 1941.

 This Act continued the operation of the principal Act, No. 1
 of 1934, as amended (supra), until 31st December, 1942.
- 1942—No. 32 of 1942: Financial Emergency Act Amendment Act, 1942. This Act continued the operation of the principal Act, No. 1 of 1934, as amended (*supra*), until 31st December, 1943.
- 1943—7 Geo. VI No. 3 (No. 8 of 1943): Financial Emergency Act Amendment Act, 1943.

This Act continued the operation of the principal Act, No. 1 of 1934 as amended (*supra*), until 31st December, 1944.

- 1944—No. 8 of 1944: Financial Emergency Act Amendment Act, 1944.

 This Act continued the operation of the principal Act, No. 1 of 1934, as amended (*supra*), until 31st December, 1945.
- 1945—No. 28 of 1945: Financial Emergency Act Amendment Act, 1945.

 This Act continued the operation of the principal Act, No.
 1 of 1934, as amended (supra), until 30th November, 1946.
- 1946—No. 59 of 1946: Financial Emergency Act Amendment Act, 1946.

 This Act continued the operation of the principal Act, No. 1
 of 1934, as amended (supra), until 30th November, 1947.

FIRST SCHEDULE.

PART V-GENERAL.

1850-14 Vict. No. 15.

This was an Ordinance to provide for the improvement of towns. It repealed certain earlier enactments, vested the property of towns and the management thereof in Town Trustees and conferred on them the necessary powers

and duties. The Ordinance, 14 Vict. No. 26 of 1851, prescribed conditions for building in towns and was repealed by 15 Vict. No. 9 of 1852, which also substituted other This latter Ordinance was amended by 19 provisions. Vict. No. 2 of 1855, which reduced the penalties for breaches of certain provisions of 15 Vict. No. 9. The City of Perth Improvement Ordinance, 1858 (22 Vict. No. 10), provided that 14 Vict. No. 15 of 1850 should be "considered as repealed in so far as relates to that City", vested all property of the city in the Perth City Council and provided thereof. This Ordinance was the management amended by the City Council Amendment Ordinance, 1864 (28 Vict. No. 10).

The Ordinance, 32 Vict. No. 5 of 1868, further amended 14 Vict. No. 15 of 1850, but only in so far as concerned the Town of Fremantle.

The Municipal Institutions Act, 1871 (34 Vict. No. 6), repealed all the abovementioned Ordinances but provided "that such repeal shall take place only so far as the same affects or in any way applies to the said City of Perth, or any Town the inhabitants of which shall, under the provisions of this Act, be incorporated".

The repeals thus effected were:—

(1) The Ordinances, 22 Vict. No. 10 of 1858 and 28 Vict. No. 10 of 1864, both being limited in their operation to the City of Perth were completely repealed.

(2) There was a complete *de facto* repeal of the Ordinance, 32 Vict. No. 5 of 1868 (which was limited to the Town of Fremantle) upon that town's subsequent incorporation under the 1871

Act (see 3 below).

- (3) The Ordinances, 14 Vict. No. 15 of 1850, 15 Vict. No. 9 of 1852, and 19 Vict. No. 2 of 1855, were repealed, but only in so far as they affected the City of Perth and the Towns of Fremantle, Guildford, Albany, Bunbury, Busselton, Geraldton and York, all of which were subsequently incorporated under the 1871 Act (see Government Gazette, 21st February, 1871, p. 41). As already mentioned, 14 Vict. No. 15 of 1850, in so far as it affected the City of Perth was also previously repealed by The City of Perth Improvement Ordinance, 1858 (22 Vict. No. 10).
- If the towns referred to above included all those previously embraced by 14 Vict. No. 15 of 1850 as amended by 15 Vict. No. 9 of 1852 and 19 Vict. No. 2 of 1855 there was, on their incorporations in 1871 a complete de facto repeal of such Ordinances as in the case of 32 Vict. No. 5 of 1868, referred to in 2 above. In any event all three ordinances, have been superseded by later local government legislation and, together with 32 Vict. No. 5 of 1868, may safely be repealed. The Secretary for Local Government agrees with this recommendation.

Year.

Act or Ordinance.

1852-15 Vict. No. 9.

This Ordinance repealed 14 Vict. No. 26 of 1851, which had prescribed conditions for building in towns and substituted fresh provisions. It was amended by 19 Vict. No. 2 of 1855, *infra* (see note to 14 Vict. No. 15 of 1850 *supra*).

1855-19 Vict. No. 2.

This Ordinance amended 15 Vict. No. 9 of 1852 (supra) by reducing the penalties for breaches of certain provisions thereof (see note to 14 Vict. No. 15 of 1850 supra).

1866-30 Vict. No. 9.

This Ordinance was the original enactment which provided for the incorporation in Western Australia of "The National Bank of Australasia", following on the original establishment in Victoria in 1858. An amending Ordinance, 31 Vict. No. 9 of 1867 (infra) repealed certain provisions of this Ordinance and substituted others in place of those repealed. In the general reconstruction of the bank which took place in 1893 all assets and liabilities of the bank as established and existing in this State under these two Ordinances were purchased and taken over by The National Bank of Australasia Limited as incorporated in Victoria on 23rd June, 1893, and therefore the bank as originally constituted ceased to exist. The National Bank of Australasia Limited agrees that both Ordinance may safely be repealed.

1867-31 Vict. No. 9.

This Ordinance repealed certain provisions contained in the Ordinance 30 Vict. No. 9 of 1866 providing for the original establishment in Western Australia of The National Bank of Australasia and substituted other provisions in place of those repealed. The National Bank of Australasia Limited agrees that both Ordinances may safely be repealed (see note to 30 Vict. No. 9 of 1866 (supra).

1868-32 Vict. No. 5.

This Ordinance amended 14 Vict. No. 15 of 1850, in so far as it concerned the Town of Fremantle (see note to 14 Vict. No. 15 of 1850 supra).

1874-38 Vict. No. 14.

This was an Act to extend the powers of the Perth City Council by empowering the Council to construct a drain or conduit from Lake Kingsford to Claisebrook and conferring the necessary further powers for this purpose of entry upon lands, removal and use of soil, inspection and alteration. The Act also provided for the payment of compensation, the purchase of land and arbitration. The Metropolitan Water Supply Sewerage and Drainage Board is satisfied that all drains in the area in which the drain authorised by this Act was or is situated are now vested in the Board, and the Council of the City of Perth agrees that the Act may safely be repealed.

1899—63 Vict.: The Cottesloe Lighting and Power (Private) Act, 1899.

This Act granted to certain persons the rights and powers necessary for the manufacture, distribution and supply of gas and electricity within the Road Board Districts of Cottesloe, Buckland Hill and Peppermint Grove. By section 39 the local authorities had the option of purchasing the undertaking at any time after 1st January, 1921, and in the exercise of this option the same was acquired by the Municipality of Cottesloe and in turn sold to the Commissioner of Railways in September, 1924, the agreement being ratified by the Cottesloe Electric Light and Power Act, No. 37 of 1925. The State Electricity Commission subsequently took over the area covered by this Act from the Commissioner of Railways under the State Electricity Commission Act, No. 60 of 1945 and the Secretary to the Commission agrees that this Act may safely be repealed.

1899—63 Vict.: The Peppermint Grove, Cottesloe, and Buckland Hill Water Supply (Private) Act, 1899.

This Act authorised William Dalgety Moore, the owner of certain lands at Claremont on which were erected "The Osborne Waterworks", or his assigns, to undertake the supplying of water throughout the Road Board Districts of Peppermint Grove, Cottesloe and Buckland Hill and conferred on Moore the rights, powers and privileges necessary for this purpose. It was also provided that the Act was not to confer on Moore any exclusive right to supply water within the area nor to affect the right of any local authority, body corporate or other person to obtain a supply of water elsewhere (section 29), and the Government was specifically empowered to construct water works without compensating the proprietor, i.e., Moore, his heirs and assigns (section 30). The responsibility for supplying water to these premises served by the undertaking authorised by this Act was assumed by the Government in October, 1903, when the Osborne Water Supply was shut off and that system connected to the Government System at Claremont (see Hansard, Volume 23 (New Series), p. 1568) from which time this Act ceased to have any effect. The Metropolitan Water Supply Sewerage and Drainage Board agrees that the Act may safely be repealed.

1909—9 Edw. VII No. 24 (No. 28 of 1909).

This Act vested Coolgardie Town Lot 1080 (C/T V. 109 F. 59) in the Municipality of Coolgardie in fee simple in trust for purposes of public recreation ground. The Under Secretary for Lands agrees that it may safely be repealed.

1914-No. 5 of 1914: The Control of Trade in War Time Act.

This Act enabled the Governor to proclaim the maximum prices of necessaries during war time. The Control of Trade in War Time Amendment Act, 1914 (22 of 1915), provided that the principal Act should not continue in force after 30th September, 1915.

1914—No. 22 of 1914: Licensing Act Amendment Act, 1914.

This Act authorised the Governor by proclamation to restrict or prohibit the sale of liquor and to vary the hours for which licensed premises might be open. Section 7 provided that the Act should continue in force until 31st March, 1915 and no longer. Its operation was extended by later Acts.

1914-No. 26 of 1914: Postponement of Debts Act, 1914.

This Act authorised the Governor on the advice of a Royal Commission to proclaim a postponement of payment of debts. Section 6 provided that the Act should continue in force for no longer than 30th June, 1915. Its operation was extended by later Acts.

- 1915—5 Geo. V No. 32 (No. 5 of 1915): Grain and Foodstuff Act, 1914.

 This Act constituted the Grain and Foodstuff Board with power to acquire grain and foodstuff. Section 25 provided that the Act should continue in force until 30th September, 1915 and no longer.
 - Grain and Foodstuff Act, 1915 (44 of 1915) provided for the transfer of the Board's assets and liabilities to the Colonial Treasurer on the expiration of the 1914 Act.
- 1915—5 Geo. V No. 34 (No. 7 of 1915): Postponement of Debts Amendment Act, 1915.

This Act enabled the Postponement of Debts Act, 1914 to continue in operation until not later than 31st December, 1915.

1915—5 Geo. V No. 36 (No. 9 of 1915): Licensing Act Amendment Continuance Act, 1915.

This Act continued the operation of Licensing Act Amendment Act, 1914 until 31st December, 1915.

1915—5 Geo. V No. 49 (No. 22 of 1915): Control of Trade in War Time Amendment Act, 1914.

See note to 5 George V No. 5 (No. 5 of 1914).

1915—6 Geo. V No. 14 (No. 47 of 1915): Postponement of Debts Act Continuation Act, 1915.

This Act enabled the continuance of the Postponement of Debts Act, 1914 until not later than 31st October, 1916.

1915—6 Geo. V No. 24 (No. 57 of 1915): Licensing Act Amendment Continuance Act, 1915.

The Licensing Act Amendment Act, 1914 was continued in force until 30th September, 1916 and for such further period as both Houses of Parliament might, before that date, resolve.

1916—6 Geo. V No. 30 (No. 63 of 1915): Sale of Liquor Regulation Act, 1915.

This Act made a number of amendments to the law relating to the sale of liquor. Section 19 provided that the Act should continue in force until 31st December, 1916 and for such further period as both Houses of Parliament might, before that date, resolve.

1916—No. 3 of 1916: Postponement of Debts Act Continuation Act, 1916.

This Act enabled the Postponement of Debts Act, 1914 to continue in operation until not later than 31st December, 1917.

1917—8 Geo. V No. 6 (No. 25 of 1917): Licensing Act Amendment Continuance Act, 1917.

By this Act the Licensing Act Amendment Act, 1914 was continued in force until 30th September, 1918 and for such further period as both Houses of Parliament might, before that date, resolve.

1917—8 Geo. V No. 9 (No. 28 of 1917): Postponement of Debts Act Continuation Act, 1917.

This Act enabled the Postponement of Debts Act, 1914 to continue in operation until not later than 31st December, 1918.

1917—8 Geo. V No. 10 (No. 29 of 1917): Sale of Liquor Regulation Act Continuation Act, 1917.

By this Act the Sale of Liquor Regulation Act, 1915 was continued in operation until 31st December, 1918.

1918—9 Geo. V No. 25 (No. 35 of 1918): Postponement of Debts Continuation Act, 1918.

This Act enabled the Postponement of Debts Act, 1914 to continue in operation until not later than 31st December, 1919.

1918—9 Geo. V No. 27 (No. 37 of 1918): Sale of Liquor Regulation Act Continuation Act, 1918.

By this Act the Sale of Liquor Regulation Act, 1915 was continued in operation until 31st December, 1919.

1918—9 Geo. V No. 28 (No. 38 of 1918): Licensing Act Amendment Continuance Act, 1918.

The Licensing Act Amendment Act, 1914 which had expired on 30th September, 1918 was revived and continued in force until 31st December, 1919.

1919—10 Geo. V No. 18 (No. 30 of 1919): Licensing Act Amendment Continuance Act, 1919.

The Licensing Act Amendment Act, 1914 was continued in force until 31st December, 1920.

1919—10 Geo. V No. 25 (No. 37 of 1919): Sale of Liquor Regulation Act Continuation Act, 1919.

The Sale of Liquor Regulation Act, 1915 was continued in force until 31st December, 1920.

1919-10 Geo. V No. 41 (No. 53 of 1919): Prices Regulation Act, 1919.

This Act authorised the appointment of Commissioners to regulate the prices of foodstuffs and necessary commodities. By section 23 of the Act was to continue in force until 31st December, 1920. Its operation was continued until 31st December, 1921, by 16 of 1920.

1919—10 Geo. V No. 45 (No. 57 of 1919): Northampton Mechanics' Institute Act, 1919.

This Act revested in the Crown Northampton Town Lot No. $31\frac{1}{2}$ (Certificate of Title Volume 8, Folio 391 granted and held in trust for the Northampton Mechanics' Institute) so that the land might be granted to Northampton District Road Board and discharged the trustees. The Under Secretary for Lands agrees that the Act may safely be repealed.

1920—No. 16 of 1920: Prices Regulation Act Amendment and Continuance Act, 1920.

The Prices Regulation Act, 1919 was amended and continued until 31st December, 1921.

1920—No. 17 of 1920: Sale of Liquor Regulation Act Continuance Act, 1920.

The Sale of Liquor Regulation Act, 1915 was continued in force until 31st December, 1921.

1920—No. 18 of 1920: Licensing Act Amendment Continuance Act, 1920.

The Licensing Act Amendment Act, 1914 was continued in force until 31st December, 1921.

1921—No. 47 of 1920: Charitable Purposes Income Deductions Act, 1920.

This Act allowed the deduction, when calculating assessable income, of payments made to certain charitable and other organisations. It was to continue in force until 31st December, 1921.

1921—No. 33 of 1921: Sale of Liquor Regulation Act Continuance Act,

The Sale of Liquor Regulation Act, 1915 was continued in force until 31st December, 1922.

1922—12 Geo. V No. 52 (No. 18 of 1922): Licensing Act Amendment Act, 1922.

This Act made it unlawful, during the continuance of the Act, to grant certain licenses under the Licensing Act, 1911. The Act continued in force until 31st December, 1922.

1925-No. 31 of 1924: Forests Act Amendment Act, 1924.

Section 41 of the Forests Act, 1918 (No. 8 of 1919) provided that the revenue of the Forests Department should be paid into the Treasury and that three-fifths of the net revenue should be credited to a fund for the improvement and re-forestation of State forests and the development of forestry. This Act authorises a portion of the revenue from Sandalwood to be applied to "The regrowth of Sandalwood" (amended by 9 of 1927 to "improvement and reforestation of Sandalwood reserves and the development of the Sandalwood industry").

31 of 1924 was however to continue in force only until 30th June, 1925 and its operation was continued by 18 of 1925 until 30th June, 1926, by 11 of 1926 until 30th June, 1927, by 9 of 1927 until 30th June, 1928, by 13 of 1928 until 30th June, 1929. Thereafter amendments to section 41 of the principal Act were continued by 28 of 1930 until 30th June, 1931 and by 41 of 1931 until 30th June, 1932.

By 27 of 1933 the same amendments were continued in force until 30th June, 1934 and were deemed to have continued in force from 30th June, 1932.

7 of 1934 continued them in force until 30th June, 1935.

Further extensions were effected by:

17 of 1936 until 31st December, 1937.

11 of 1937 until 31st December, 1938.

1925—No. 18 of 1925: Forests Act Amendment Act, 1925. See note to 31 of 1924.

This Act provided for the marketing of dried fruits and constituted a Dried Fruits Board.

Section 35 provided that the Act was to continue in force until 31st March, 1930.

Adequate power to maintain a railway constructed pursuant to one of these Acts is conferred by the Public Works Act, 1902-1961.

In the case of those Acts comprising Part I it is necessary to preserve the limits of deviations as originally authorised and this has been effected by subclause (2) of clause 3 of the Bill.

The railways authorised by the Acts comprising Part II have all since been discontinued, and it is therefore not necessary to preserve the limits of deviations as with those Acts in Part I and they are accordingly included in a separate part.

PART III—DISCONTINUANCE ACTS.

These Acts authorised the discontinuance of various railways which are identified by the short titles with the exception of the Railways Discontinuance Act, 1928 as to which a brief note appears.

PART IV—MISCELLANEOUS RAILWAY ACTS.

The three Acts comprising this part deal with various matters associated with railways.

The Commissioner of Railways agrees that all the Acts comprising this Schedule may safely be repealed.

The Tramways Purchase Act (31 of 1912) ratified an agreement between the Perth Electric Tramways Limited as vendor and the Agent-General as agent for the Government of the State as purchaser for the sale of the vendor's undertaking.

Section 6 provided that as from the notification in the *Government Gazette* of the fact of the completion of the purchase, certain Acts mentioned in the Second Schedule, which included these four Acts, should be repealed. The appropriate notice appeared in the *Government Gazette* of 8th August, 1913, p. 3212, and these four Acts should be taken to have been repealed on that date. 1896—60 Vict. No. 25: Colonial Passengers Act, 1896.

This enactment was intended to replace certain earlier legislation. Section 37 provided that the enactment should not come into operation until Her Majesty's pleasure therein had been publicly signified, but no assent was ever given.
