- (c) how many cases are from the Kununurra office;
- (d) are there any full-time equivalents currently unfilled in either of those offices; and
 - (i) if so, what is the position title for each, what is the reason for the vacanc(ies) and for how long have those postion(s) been vacant;
- (e) what measures are presently being deployed for unallocated cases; and
- (f) what steps are being taken to reduce the number of unallocated cases?

2544. Mr M.P. Whitely to the Minister for Forestry

I refer to the proposal to log Mundlimup Coupe 0309. In September 2009 the Forest Products Commission expected in the order of 300 hectares to be logged pending final coupe design and in relation to this, I ask:

- (a) has that coupe design been finalised; and

- (1) Has the Minister's department made an additional cut to its fleet budget of \$376,000 since last year's State Budget; and
 - (a) if not, what is the quantum of any additional fleet savings that have been made since last year's State budget?
- (2) Will the Minister please provide details of how any additional fleet savings have been, or will be, achieved?
- (3) What will be the impact of any cuts described as 'fleet savings'?

2547. Mrs M.H. Roberts to the Minister for Education

- (1) Has there been a cost blow-out of \$5,573,000 for Gold State Superannuation beyond what was allocated in the 2009–2010 State Budget?
 - (a) if not, what blow-out has there been in Gold State Superannuation?
- (2) Why has there been a blow-out?
- (3) Will the Minister provide reasons as to why her department was unable to accurately estimate its liabilities to Gold State Superannuation?
- (4) Will the Minister be able to provide a more accurate estimate for the 2010–2011 State Budget; and
 - (a) if not, why not?

2548. Mrs M.H. Roberts to the Minister for Education

- (1) How many government schools have closed between 1 October 2008 and 1 March 2010?
- (2) What was the name and location of each school closed?
- (3) What was the number of students at each year level in the last complete school year that the school operated?
- (4) Who owned the land that the school was based on in each instance?
- (5) Were any classrooms removed to other locations after a school was closed; and
 - (a) if so, from which locations, to which locations, and at what cost?

- (6) What savings have been achieved as a result of each closure?
- (7) Which schools were the displaced children moved to in each instance?
- (8) How many students attending the schools that the Minister closed are now enrolled in the School of Isolated and Distance Education (SIDE)?
- (9) What year level are each of the displaced children now enrolled in SIDE?
- (10) Which schools are currently under consideration for closure?
- (11) What was the average number of students at each school that was closed during that period?
- (12) How many schools currently have the average number of students referred to in (11), or less than this average number, and which schools are they?
- What amount of money did the Minister's department plan on saving through school closures when last year's State Budget was agreed?
- How much money has the Minister's department actually saved through school closures in 2009–2010?
- Will the Minister's department need to make up any deficiency in school closure savings not achieved this year in 2010–2011?
