5475. Mr M. McGowan to the Minister representing the Minister for Housing:

I refer to Tender HOU1731115 and the inspection of electrical safety devices in public housing and other residential properties, and ask:

- (a) how many properties overall have been inspected as at 14 June 2016;
- (b) in which contract areas were the properties inspected, and what is the number of inspections in each of these contract areas;
- (c) of the number outlined in (a), how many properties overall have been found to have defective electrical devices;
- (d) what is the breakdown of the number outlined in (c) per contract area inspected; and
- (e) of the number outlined in (c), how many have had defective electrical issues remediated?

5476. Mr M. McGowan to the Minister representing the Minister for Housing:

Has the evaluation associated with Tender HOU1151915 concerning the Delivering Affordable Housing to Key Workers in Regional Western Australia program been completed:

- (a) in relation to utilities, can the Minister outline the specific measures the Government is:
 - (i) undertaking; and
 - (ii) contemplating;
- (b) in relation to land use, can the Minister outline the specific measures the Government is:
 - (i) undertaking; and
 - (ii) contemplating;
- (c) for the years 2012-2013, 2013-2014, 2014-2015, 2015-2016 can the Minister provide WA's:
 - (i) total greenhouse gas emissions;
 - (ii) percentage annual increases in greenhouse gas emissions from the previous year; and
 - (iii) per capita emissions; and
- (d) for the years 2012-2013, 2013-2014, 2014-2015, 2015-2016 can the Minister indicate WA's ranking amongst all Australian states and territories in terms of:
 - (i) total emissions;
 - (ii) annual increases in greenhouse gas emissions; and
 - (iii) per capita emissions?

5480. Ms S.F. McGurk to the Minister for Seniors and Volunteering:

- (1) Why is the eligibility of the Seniors Card based on the amount of hours a person works rather than the amount of income they earn?
- (2) Is the Minister aware that a lawyer earning \$150 an hour but working 24 hours a week can access a Seniors Card, but a person on the minimum wage working 27 hours a week isn't entitled to the card?

5481. Mr P.B. Watson to the Minister for Police:

I refer to accidents involving restricted access vehicles and ask:

- (a) can the Minister please advise the number of reported accidents involving restricted access vehicles for the years 2010/11, 2011/12, 2012/13, 2013/14, and 2014/15 in each of the following police districts:
 - (i) Great Southern;
 - (ii) South West;
 - (iii) Mid West Gascoyne;
 - (iv) Wheatbelt; and
 - (v) Goldfields Esperance?

5482. Mr P.B. Watson to the Minister for Lands:

I refer to the Middleton Beach Activity Centre Scheme Amendment and Structure Plan and ask:

- (a) LandCorp has advised the public that a permitted height up to 12 storeys is required for the hotel site, can the Minister please advise on what information LandCorp relied on when deciding that a height of up to 12 storeys was required for the viability of the hotel on that site;
- (b) on what information did LandCorp rely on when deciding that a hotel of eight storeys or less would not be viable; and
- (c) the LandCorp concept plan for the Middleton Beach Activity Centre shows a five storey development immediately next to the existing foreshore reserve, when the structure plan guidelines state a stepped development from ground floor to three storeys. Can the Minister advise why LandCorp is promoting a development that is contrary to its own land use planning guidance?
