 - (xi) on average, how frequently were these vehicles cleaned;
 - (xii) on average, how frequently were these vehicles detailed;
 - (xiii) what was the expenditure on cleaning vehicles broken down by hospital; and
 - (xiv) what was the expenditure on detailing vehicles broken down by hospital?
