FIRST SESSION OF THE THIRTY-NINTH PARLIAMENT

THURSDAY, 8 MAY 2014

1. Meeting of Assembly

The Assembly met at 9.00 a.m. pursuant to adjournment.

The Speaker took the Chair.

Prayers were read.

2. Speaker's Statement – Presentation of the Budget

The Speaker advised members that the Budget would be presented at 2.00 p.m., and that members' 90 second statements would occur at 12.20 p.m. and Questions without Notice at 12.30 p.m.

3. Speaker's Statement – Media and Televising

The Speaker reminded members that he had approved a media presence in the Chamber to film the presentation of the Budget at 2.00 p.m.
