5. Petitions

Puppy Farms – Mr W.J. Johnston presented a petition from 16 persons asking the Legislative Assembly to call on the Barnett Government to ban the sale of puppies in pet stores and online across Western Australia (P. 421).

Bentley Hospital Surgical and Maternity Services – Mr W.J. Johnston presented a petition from 35 persons asking the Legislative Assembly to call on the Barnett Government to retain local health services, particularly surgical and maternity services at Bentley Hospital so the local community can access health services close to where they live (P. 422).

Save Bentley Hospital – Mr W.J. Johnston presented a petition from 76 persons requesting that the Legislative Assembly calls on the Barnett Government to retain local health services at Bentley Hospital so the local community can access these services close to home, in particular but not limited to – surgical, maternity and physiotherapy services (P. 423).

Save Western Power – Mr W.J. Johnston presented a petition from 96 persons asking the Legislative Assembly to stand against the Barnett Government's privatisation of Western Power (P. 424).

Compensate Genetically-Modified Free Framers – Mr M.P. Murray presented a petition from 207 persons asking the Legislative Assembly to urge the Western Australian Government to introduce Farmer Protection Legislation to compensate any non-GM farmer who suffers economic loss from GM contamination (P. 425).

Lanco Griffin Coal – Mr M.P. Murray presented a petition from 43 persons requesting that the Members of the Legislative Assembly through the Minister for Commerce request Worksafe to conduct an inquiry into Lanco Griffin Coal's management style and effect on employee mental health (P. 426).

Wellington National Park – Mr M.P. Murray presented a petition from 323 persons asking the Legislative Assembly to expand the Wellington National Park to include the State Forests of Arcadia, Yabberup, Lowden, Mungalup and the Wellington Discovery Forest Reserve (P. 427).

Freight Trains through Bibra Lake – Mr P.C. Tinley presented a petition from 30 persons asking the Legislative Assembly to consider introducing a curfew on trains late at night; limiting the speed of trains through the area; ensure that train horns are only used when necessary and refurbishing the track to mitigate noise and vibration issues (P. 428).

Traffic Congestion in Munster – Mr F.M. Logan presented a petition from 50 persons asking the Legislative Assembly to call on the Barnett Government to modify the layout at Stock Road to allow for the duplication of Beeliar Drive to continue and the Mayor Road and Rockingham Road roundabout to be widened to allow the free flow of traffic (P. 429).
