## 5879. Ms J. Farrer to the Minister for Housing:

I refer to Questions on Notice Nos 5687 and 3168 regarding Department of Housing properties, and I ask:

- (a) how many people were housed in Wyndham from the waitlist between October 2014 and August 2016; and
- (b) please explain why there has been such a large reduction of people on the waitlist for Wyndham?
