THE PARLIAMENT of Western Australia begun and held in the City of Perth on Thursday, the Eleventh day of April in the Sixty-first year of the Reign of Her Majesty Queen Elizabeth II, and in the Year of Our Lord, Two thousand and thirteen.

A ballot being required, Mr C.J. Barnett called on Mr A. Krsticevic and Mr D.A. Templeman to act as scrutineers.

Mr C.J. Barnett announced the results of the ballot as follows –

Mr C.J. Barnett declared Mr M.W. Sutherland elected as Speaker.

Mr M.W. Sutherland assumed the Chair.

6. Presentation of Speaker

The Premier informed the Legislative Assembly that His Excellency the Governor would be pleased to receive the Speaker and such members as desired to accompany him at 12.30 p.m. that afternoon.

Sitting suspended from 12.10 p.m. to 2.45 p.m.
