## FIRST SESSION OF THE THIRTY-NINTH PARLIAMENT

## THURSDAY, 18 JUNE 2015

## 1. Meeting of Assembly

The Assembly met at 9.00 a.m. pursuant to adjournment. The Speaker took the Chair.

Prayers were read.

#### 2. Petitions

Sub-sonic Vibration Disturbance – Mr C.J. Tallentire presented a petition from 515 persons requesting the Legislative Assembly to call upon the State Government to review the effectiveness of the regulations under the *Environmental Protection Act 1986* to enable proper measurement of disturbance from low frequency bass units and to enable Local Government and Police to investigate reports of low frequency disturbances (P. 258).

Perth Freight Link: Roe Highway Extension – Mr F.M. Logan presented a petition from 130 persons requesting the Legislative Assembly to call on the Barnett Government to reverse their decision to allow the Roe Highway Extension (eastern end of the Perth Freight Link) to go ahead and to allocate the funding awarded to this project to other alternative solutions to freight transfer issues (P. 259).

Gene Technology Act 2006 – Mr W.R. Marmion presented a petition from 56 persons requesting that the Legislative Assembly call for an independent review of the Gene Technology Act 2006 by a parliamentary committee and to call for the Office of Gene Technology Regulator to include independent science on health and environmental safety risk assessments of GM crops, associated pesticides and GM food (P. 260).

Genetically Modified Crops Free Areas Act 2003 – Mr W.R. Marmion presented a petition from 41 persons requesting that the Legislative Assembly call for an independent review of the Genetically Modified Crops Free Areas Act 2003 by a parliamentary committee, to support GM-free farming and to urge the Western Australian Government to introduce farmer protection legislation to compensate any non-GM farmer who suffers economic loss from GM contamination (P. 261).
