7. Notices of Motion

Acting Speaker's Statement – Notice of Motion to Delete Part of a Bill

The Acting Speaker advised members that the member for Warnbro had given notice of a motion to suspend standing orders to enable him to move a motion to delete an entire part of a Bill and to facilitate some associated matters. She informed members that this notice of motion would appear at the back of the Notice Paper in the 'Notices and Amendments' section under the name of the Bill. The other usual form of notice which went in that part of the Notice Paper was a notice to extend the scope of a Bill. The usual practice of the House had been to permit a member to give notice of a motion to extend the scope of a bill by handing a signed notice to the Clerk. That notice was then placed on the Notice Paper in the 'Notices and Amendments' section. The Acting Speaker advised members that there was a significant difference between a notice to suspend Standing Orders in relation to the consideration in detail part of a Bill and a notice to extend the scope of a Bill. Giving notice to suspend Standing Orders changed the voting requirement from an absolute majority to a simple majority, in accordance with Standing Orders, it should be given orally in the House.
